

**Minutes of the
Oklahoma Corporation Commission
State of Oklahoma**

March 6, 2025 –9:30 a.m.

These are the minutes for the Corporation Commission’s (“Commission”) special meeting conducted in accordance with the Open Meeting Act on March 6, 2025, in the Concourse Theater, Suite C50, Will Rogers Memorial Office Building, 2401 North Lincoln Boulevard, Oklahoma City, Oklahoma 73105. Archived Commission meeting recordings may be accessed on the Commission’s website.

The notice and agenda for the meeting were publicly posted at the principal office of the Commission at the Will Rogers Memorial Office Building, 2401 North Lincoln Boulevard, Oklahoma City, Oklahoma 73105 at 9:20 a.m., March 4, 2025, by Commission employees acting under the direction of Chairman Kim David. Notice was provided in writing to the Oklahoma Secretary of State at least forty-eight hours in advance of the meeting, and the notice and agenda are also made available to the public on the Commission’s website, oklahoma.gov/occ. A copy of the notice and agenda is attached to these minutes as Appendix A.

Chairman David called the meeting to order at 9:31 a.m.

Members present were Chairman Kim David, Commissioner J. Todd Hiett, and Commissioner Brian Bingman. A quorum of the Commission was present. Interested persons participated in the meeting in person or by teleconference/videoconference when and as authorized.

Commissioner David announced the agenda item and recognized Mark Willingham, chief legal counsel, to provide an update and briefing on the status of House Bill 2603. Discussion was held. Commissioner David **CALLED FOR A VOTE** on a motion that the Corporation Commission publicly oppose HB 2603

in its current form and continue to oppose any legislation which would move Oklahoma Corporation Commission Transportation Division staff away from this agency, and authorize Commission staff to inform members of the Oklahoma legislature of Oklahoma Corporation Commission opposition to any such move of personnel.

Commissioner Bingman requested an amendment to the proposed motion, which was agreed to and supported by Commissioner David. Commissioner David **CALLED FOR A VOTE** on the amended motion that *the Corporation Commission publicly oppose HB 2603 in its current form and continue to oppose any legislation which would move Oklahoma Corporation Commission Transportation Division staff and duties away from this agency, and authorize Commission staff to inform members of the Oklahoma legislature of Oklahoma Corporation Commission opposition to any such move of personnel and duties.*
