The condition of this obligation is that whereas the above bounden Principal proposes to operate a hydrocarbon recycling/reclaiming facility, a commercial recycling facility, a commercial disposal well, or a flow back water pit with a capacity in excess of 50,000 barrels at the location designated above pursuant to OAC 165:10-8-1, et seq., OAC 165:10-9-4, or OAC 165:10-5-5 or OAC 165:10-7-16(f) and such Principal agrees to operate said hydrocarbon recycling/reclaiming facility, commercial recycling facility, commercial disposal well, or flow back water pit in compliance with Oklahoma Corporation Commission rules and pursuant to the manner prescribed by the laws of the State of Oklahoma and the General Rules and Orders of the Corporation Commission.

If the above bounden operator shall properly close and reclaim the hydrocarbon recycling/reclaiming facility, commercial recycling facility, commercial disposal well or flow back water pit covered by this instrument at the time and in the manner prescribed by the laws of the State of Oklahoma and the General Rules and Orders of the Oklahoma Corporation Commission of the State of Oklahoma, then this obligation shall expire at that time upon written consent from the Oklahoma Corporation Commission; otherwise, the same shall be and remain in full force and effect. It is a condition of this instrument that it is continuous in nature until released by the Commission; in no event will this instrument expire, cancel, modify, or terminate without prior written consent of the Commission.

This obligation may be terminated upon six (6) months' notice in writing by certified mail, return receipt requested, to the Oklahoma Corporation Commission's Surety Department, Oil and Gas Conservation Division, and evidence furnished of alternate surety which is acceptable to the Commission's Oil and Gas Conservation Division, if such alternate surety is required. Any attempted termination of this obligation is not effective, however, until this obligation is released by the Surety Department of the Commission's Oil and Gas Conservation Division in writing.

PROVIDED, HOWEVER, the aggregate liability of the surety hereunder this agreement shall in no event exceed the total sum of this financial instrument.
