Chair Alan Myers (ITC Great Plains) called the meeting to order at 10:32 a.m. CT. He reviewed the purpose of the meeting, reminded members of the meeting principles, reviewed proxy information, and presented the upcoming draft motion.

## APPROVAL ITEMS

### 2. **Cost Allocation Working Group**

Clint Savoy (SPP) and Aaron Shipley (SPP) updated the committee on the efforts to finalize RR620 Joint Targeted Interconnection Queue (JTIQ). Clint detailed the framework for the JTIQ process, and Aaron explained the purpose and benefits of the revision request. Aaron also shared how RR620 was received by other stakeholder groups as well as the remaining steps needed to approve this proposal and move closer to a regulatory filing. *Heather Starnes (Missouri Public Utility Alliance) moved and Jason Mazigian (Basin Electric Power Cooperative) seconded to approve RR620 Joint Targeted Interconnection Queue as presented.* The motion passed with 88% approval.
