# **MINUTES**

### LINK TO MATERIALS

## **ADMINISTRATIVE**

Chair Alan Myers (ITC Great Plains) called the meeting to order at 8:05 a.m. CT. He and MOPC staff secretary Lanny Nickell (SPP) reviewed proxies, new members, action items, the Revision Request (RR) summary, and upcoming draft motions.

# **APPROVAL ITEMS (2-6)**

Walt Shumate (ENGIE North America) moved and Jason Mazigian (Basin Electric Power Cooperative) seconded to approve the consent agenda. The motion passed with 99% approval.

## 3. Resource Adequacy Initiatives

## a. RR621 Fuel Assurance Policy

Casey Cathey (SPP) detailed the most recent developments on the proposed Fuel Assurance policy with the committee. Colton Kennedy (OPPD) shared the perspective of the Supply Adequacy Working Group's (SAWG) conversations on the proposed revision request. Commissioner Kristie Fiegen, chair of the Resource and Energy Adequacy Leadership (REAL) Team, spoke about REAL Team's deliberations on this policy proposal. John Luallen (SPP Market Monitoring Unit) spoke about the Market Monitor's perspective on this revision request. Robert Pick (Nebraska Public Power District) moved and Jason Mazigian (Basin Electric Power Cooperative) seconded MOPC approval of RR621 Fuel Assurance Policy as approved by SAWG on April 22, 2024. The motion passed with 92% approval.

## b. RR622 Planning Reserve Margin Policy

Casey Cathey (SPP) provided details for the committee on the proposed Planning Reserve Margin (PRM) Policy. He shared that this initiative was intended to ensure that load responsible entities are appropriately planning for capacity in both the winter and summer seasons. Colton Kennedy (OPPD) shared the perspective of the Supply Adequacy Working Groups' (SAWG) decisions on this policy recommendation. Commissioner Kristie Fiegen, chair of the Resource and Energy Adequacy Leadership (REAL) Team, spoke about the lengthy REAL Team deliberations on this policy proposal and the careful considerations for their competing recommendation. John Luallen (SPP Market Monitoring Unit) spoke about the Market Monitor's perspective on the proposed policy. Richard Ross (AEP Southwestern Transmission) moved and Adam Graff (Heartland Consumers Power District) seconded MOPC approval of RR622 Planning Reserve Margin Policy as approved by SAWG (33% Winter Season Base PRM and 16% Summer Season PRM) on April 22, 2024, while also including SPP staff edits related to Safe Harbor and Sufficiency Valuation Curve for two years after implementation date of PRM increase. Al Tamimi (Sunflower Electric Power Corporation) moved to amend the previous motion and Joe Lang (Omaha Public Power District) seconded to revise the Winter PRM from 33% to 36%. The motion to amend the pervious motion failed with only 33% voting in favor. The original motion was then put to a vote by the group, and that motion passed with 75% approval.

## c. 2025-2026 Resource Adequacy Initiative Update

Natasha Henderson (SPP) reviewed the Resource Adequacy Study workplan with the committee. She noted that several timeline targets in the workplan were being prioritized and some items may shift around. Lanny Nickell (SPP) reminded the committee about the governance process for Resource Adequacy issues.

### 4. Project Cost Working Group

Matt Jackson (SPP) updated the committee on the Q3 In-Service Date Delay Report Appendix 2. He provided details about projects that have an estimated in-service date past their first reported in-service date, and he noted that several upgrades have moved to complete/in-service since the In-Service Date Delay efforts have been initiated. Maurice Moss (American Clean Power Association) moved and Mo Awad (Evergy Kansas Central) seconded MOPC accept the current Estimated In-Service Date [of the upgrades identified in the Quarterly Project Tracking Report] to be used to evaluate future In-Service Date deviations. The motion passed with 100% approval.

### 5. Market Working Group

## a. RR628 Price Formation During Load Shed and Emergency Energy Assistance

Richard Ross (AEP) presented RR628 Price Formation During Load Shed and Emergency Energy Assistance. Richard Ross (AEP Southwestern Transmission) moved and Jim Flucke (Evergy Kansas South) seconded to approve RR628 which proposes to dispatch the system based on the true obligation and price the system using the obligation without the impact of the load shed and emergency energy assistance. The motion passed with 95% approval.

## b. RR635 Market Storage Resources and Self-Charging

Richard Ross (AEP) explained RR635 (SIR203, SIR695) Market Storage Resources and Self-Charging. This proposed revision request will identify all withdrawals that do not provide a market service and clarify the requirements for Market Participants registering Market Storage Resources to become a transmission customer. Richard Ross (AEP Southwestern Transmission) moved and Mo Awad (Evergy Kansas Central) seconded to approve RR635 MSR Registration and Self-Charging as presented. The motion passed with 91% approval.

### 6. **Generation Interconnection Advisory Group**

Natasha Henderson (SPP) presented a waiver to delay the start of the Phase 1 2024 DISIS and a waiver to delay opening the 2025 DISIS allowing for interim provisional service. She noted that delaying the start of the Phase 1 2024 DISIS analysis will save customers money by avoiding additional studies and will allow for a more accurate information to be provided for customers to make decisions. Mike Wise (Golden Spread Electric Cooperative) moved and Derek Brown (Prairie Wind Transmission) seconded to endorse a waiver to modify the start of Phase 1 of the 2024 DISIS to begin at the completion of the first planned Phase 2 Restudy of the 2023 DISIS, a waiver to modify the start of the open season of the subsequent DISIS to begin at the earlier of 1) April 1, 2026, or 2) at the completion of Decision Point 2 of the 2024 DISIS, and close October 31, 2026, and an Interim waiver for provisional service for IGIA to become GIAs in the subsequent DISIS. The motion passed with 81% approval.

# **INFORMATIONAL (7-18)**

### 7. Cost Allocation Working Group and Staff

Lise Trudeau (Minnesota Public Utility Commission) and Charles Locke (SPP) updated the committee on the Cost Allocation Working Groups progress on Holistic Integrated Tariff Team (HITT) initiative C1, which aims to decouple schedules 9 and 11 transmission pricing zones.

#### 8. Staff

Derek Hawkins (SPP) presented an overview of the operational event from April 28, 2024. He pointed

out the causes and key contributing factors of the event, and shared the analysis staff completed that detailed the lessons learned. Finally, he shared six recommendations staff identified to improve operational effectiveness.

#### 9. Staff

Nick Parker (SPP) briefed the committee on the Integrated Transmission Plan (ITP) studies currently in progress. He noted that the 2024 and 2025 ITP Assessments are on track.

#### 10. Staff

Nick Parker (SPP) provided an overview of the 2024 ITP Portfolio to the committee. He presented a summary of the portfolio development process that highlighted challenges in different regions of the SPP footprint.

## 11. Staff

Jennifer Swierczek (SPP) shared an update on the Generator Interconnection Queue backlog mitigation plan and the Contingent Facility issue.

#### 12. Staff

Mike Riley (SPP) updated the committee on the recent developments related to FERC Order 1920. He noted that the Order requires SPP to make several changes and additions to its long-term planning processes. The Order also requires compliance with its cost allocation principles and transparency coordination efforts with state regulatory entities. Additionally, the Order contains obligations to account for technologies applicable to long-term planning solutions and requirements to account for these new long-term planning principles in interregional processes. SPP staff is working to identify its compliance with the Order.

#### 13. **Staff**

Sunny Raheem and Steve Purdy (SPP) gave an update on the Consolidated Planning Process Task Force's (CPPTF) current work. Specifically, they reviewed an update on Consolidated Planning Process (CPP) timelines, Network Resource Interconnection Service (NRIS+) activities, recent CPPTF entry fee discussions, and the potential need for a Special Study.

#### 14. Staff

Charles Yeung (SPP) asked the committee for input on how best to manage the high volume and fast pace of standards development. After presenting the current state of the NERC standard landscape, members shared several comments with Charles to take back to the next NERC meeting.

## 15. **Staff**

Yasser Bahbaz (SPP) provided an update on the latest developments related to FERC Order 2222 and SPP's compliance approach.

#### 16. Staff

Richard Ross (AEP Southwestern Transmission) briefed the committee on the challenges managing regulation control status. He encouraged members to more proactively manage their control status.

## 17. Staff

Matt Jackson (SPP) summarized the In-Service Date Delay improvements introduced by the Project Cost

Working Group since its approval in January 2024. He shared details about the phased approach to impelment these improvements and noted where members could access relevant reports.

### 18. **Staff**

Lanny Nickell (SPP) recapped the items approved this quarter and previewed the items expected to come before the committee in future meetings.
