## ADMINISTRATIVE

Chair Alan Myers (ITC Great Plains) called the meeting to order at 1:01 p.m. CT. He reviewed the purpose of the meeting, reminded members of the meeting principles, reviewed proxy information, and presented the upcoming draft motion.

## APPROVAL ITEMS

### 2. **Transmission Working Group/Economic Studies Working Group**

Kirk Hall (SPP) and Sunny Raheem (SPP) updated the committee on efforts to further evaluate the staging of two projects from the 2024 ITP, specifically Elm Creek–Tobias and Buffalo Flats–Delaware 345kV transmission projects. This work was completed by the TWG and ESWG in response to a directive from the SPP Board of Directors to delay the need by date staging until no later than the board's December 9, 2024, meeting.

*Larry Holloway (KPP Energy) moved and Jeff Wells (NextEra Energy Resources) seconded to approve the Elm Creek – Tobias project be staged as 12/1/2028 based upon the version of the tariff and ITP Manual that was used to determine current need dates as recommended by SPP staff for the 2024 ITP. The motion passed with 71% approval.*

*Jeff Wells (NextEra Energy Resources) moved and Noman Williams (GridLiance High Plains) seconded to approve the Buffalo Flats – Delaware project be staged as 12/1/2028 based upon the version of the tariff and ITP Manual that was used to determine current need dates as recommended by SPP staff for the 2024 ITP.*

*Mo Awad (Evergy Kansas Central) moved and Olivia Hough (City Utilities of Springfield) seconded to amend the previous motion to approve the Buffalo Flats – Delaware project be staged as 12/1/2025 with Delaware – Monett to resolve the remaining Winter Storm Elliott Target Area Reliability Needs, consistent with SPP staff's incremental staging approach, and based upon the version of the tariff and ITP Manual that was used to determine current need dates as recommended by SPP staff for the 2024 ITP. The motion to amend the previous motion passed with 72% approval.*

*Steve Gaw (Advanced Power Alliance) moved and Robert Helton (ENGIE North America) seconded to amend the previous motion to approve the Buffalo Flats – Delaware project be staged as 12/1/2025 to resolve the*

*remaining Winter Storm Elliott Target Area Reliability Needs, consistent with SPP staff's incremental staging approach.* The motion to amend the previous motion passed with 86% approval.

The amended motion—to approve the Buffalo Flats – Delaware project be staged as 12/1/2025 to resolve the remaining Winter Storm Elliott Target Area Reliability Needs, consistent with SPP staff's incremental staging approach—passed with 75% approval.
