AGENDA ITEM 1 – ADMINISTRATIVE ITEMS

Chairman Kristie Fiegen (SD PUC) called the meeting to order, conducted the roll call, and reviewed the agenda. John Krajewski (NPRB) held proxy for Chuck Hutchinson (NPRB) as necessary, and Andrew Lachowsky (AECC) held proxy for Buddy Hasten (AECC).

MOTION: To approve minutes from August 21, 2024. Cindy Ireland (APSC) motioned / David Osburn (OMPA) seconded. The motion passed unanimously.

Agenda Item 2 – Standing Updates

- a. **FERC Resource Adequacy** Justin Hinton (SPP Staff) provided an update on Resource Adequacy FERC filings. All filings are currently pending and awaiting an order. A Winter/Summer PRM filing is expected to be filed soon.
 - **Supply Adequacy Working Group (SAWG)** Colton Kennedy (OPPD) provided an update on SAWG. Mr. Kennedy indicated that the SAWG is working on the 2029 PRM, the 2025 LOLE study scope, and the ECLL study scope. At the October REAL Team meeting, SAWG will present a discussion and request feedback on the 2029 Planning Reserve Margin, with a vote anticipated in November 2024.
- b. **Operations Update** CJ Brown (SPP Staff) indicated there were approximately 15,000 MW of maintenance outages. The recent resource alert was issued due to tight conditions caused by the outages in conjunction with low wind.
- c. **2024 Resource Adequacy Policy Targets –** Natasha Henderson (SPP Staff) reviewed the items remaining on the 2024 work plan.

AGENDA ITEMS 3 – REAL/SAWG 2025-2026 WORK PLAN

Natasha Henderson (SPP Staff) presented the 2025 work plan, including the dates anticipated for REAL policy approval. Ms. Henderson indicated that there were two new items. First, Cost and Benefit Reliability Standards based on a previous REAL affordability/reliability action item. The second new item is the Value of Resiliency Determination, which is also a result of discussion from the last REAL Team meeting and action item.





An action item was established for Staff to provide a timeline ranking of when the items will be presented to the REAL Team.

MOTION: REAL endorses the 2025 work plan as presented. Shawnee Claiborn-Pinto motioned (PUCT) / Ray Hepper (SPP BOD) seconded. The motion passed unanimously.

AGENDA ITEM 4 – 2025 REAL TEAM MEETING DATES

Kim O'Guinn (SPP Staff) presented the 2025 REAL Team meeting dates for consideration.

MOTION: REAL approves the 2025 meeting dates as presented. Dave Osburn (OMPA) motioned / Chuck Hutchinson (NPRB) seconded. *The motion passed unanimously*.

AGENDA ITEM 5 – RR 632 DATE CHANGE IN ATTACHMENT AA

Brad Payne (SPP Staff) presented RR632 for a vote.

MOTION: SAWG recommends that the REAL Team approve RR632 – Date Change in Attachment AA, as presented. Andrew French (KCC) motioned / Shawnee Claiborn-Pinto (PUCT) seconded. *The motion passed unanimously*.

AGENDA ITEM 6 – GI IMPROVEMENTS

Steve Purdy (SPP Staff) presented options for creating a process that will expedite the study and connection of new generation that will contribute to achieving or maintaining the PRM. An update is expected at the October meeting.

AGENDA ITEM 7 – DEMAND RESPONSE OPERATIONAL RISK

Natasha Henderson and CJ Brown (SPP Staff) discussed the real-time reliability risk and challenges associated with accreditation. Staff will lead the development of a holistic policy proposal in conjunction with a small subset of stakeholders. Staff will hold educational sessions throughout the policy development to gather feedback from members. Once a proposal is developed, it will be presented to the REAL Team for approval. Once the REAL Team approves the proposal, it will be presented to the relevant working groups for feedback and consideration before being submitted to the REAL Team for final approval.

AGENDA ITEM 8 – PRM TRANSITION MECHANISMS

CJ Brown (SP Staff) presented RA Load Mitigation Options for the transition period. Mr. Brown discussed the criteria for mitigation options and provided examples. Staff will continue discussions with ORWG to get feedback and provide an update to the REAL Team at a future meeting.





AGENDA ITEM 9 – AQ STUDY

Natasha Henderson and Jason Davis (SPP Staff) reviewed the current AQ process and presented the new provisional load process and considerations for cost allocation. Staff intends to present a White Paper to MOPC in October for feedback.
