### **In accordance with 17 O.S. §160.23**

B. Pursuant to the Oklahoma Wind Energy Development Act, 17 O.S. §160.23, on and after January 1, 2026, no new wind energy facility may commence operations in this state unless the developer, owner, or operator of the facility applies to the Federal Aviation Administration (FAA) for installation of a light-mitigating technology system that complies with FAA regulations provided in 14 C.F.R., Section 1.1 et seq. and to the Federal Communications Commission (FCC) regarding frequency licensing and antenna structure registration, as applicable, as provided in 47 C.F.R., Sections 90.101 and 17.4. If approved by the FAA and the FCC, the developer, owner, or operator of such facility shall install the light-mitigating technology system on the facility within twenty-four (24) months after receipt of approval.

C.1. Any developer, owner, or operator of a wind energy facility that commences commercial operations in this state on or before the effective date of this act without a light-mitigating technology system shall apply to the FAA for installation of the system in compliance with FAA regulations provided in 14 C.F.R., Section 1.1 et seq. and to the FCC regarding frequency licensing and antenna structure registration, as applicable, as provided in 47 C.F.R., Sections 90.101 and 17.4 upon the occurrence of either:

- a. the repowering of the wind energy facility, or
- b. entrance into or renewal of a new power offtake agreement.
