Presentation: OCCY Parent Partnership Board: Overview and Update Regarding this Statutorily Created Board

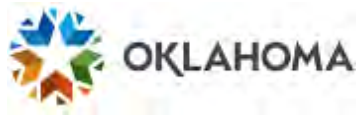

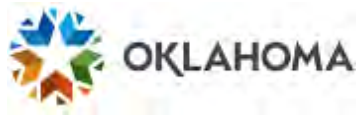

SUMMER AND BEYOND

Any discussion of pandemic-related concerns must begin with swiftly addressing unfinished learning and determining ways to jump-start the 2021-22 school year. This work is underway in many districts, with local investments in summer school and other extended and accelerated learning opportunities.

Summer 2021 will be unlike any other. Oklahoma families are strongly encouraged to contact their local districts and trusted community organizations like Boys and Girls Clubs, the YMCA, tribal nations, faith-based organizations and other community partners to learn more about their summer offerings. Programming will vary around the state, from targeted academic enrichment to camps focused on fine arts, STEM, physical activity and more.

But we must also look beyond the summer. Sustained collaboration will help ensure that state and local investments of federal coronavirus relief dollars position Oklahoma schools and students for lasting success.

THE PLAN

Ready Together Oklahoma is built on a commitment to doing what's best for all Oklahoma schoolchildren in the short and long term. All resources will be organized within five sections: Student Learning and Success, Prioritizing Health and Well-Being, Ensuring Equity for All, Supporting Teachers and Leaders and Embracing Families and Communities.

The plan's web page serves as a hub for two categories of resources designed to support schools and communities as they determine the most effective uses of federal relief funds. First is evidence-based, curated guidance documents with links to established research for educators to consider as they implement programs that meet the needs of their communities, determine the most effective uses of local relief funds and engage families and other stakeholders in supporting student learning and well-being.

Guidance documents will be published in three phases:

- Now through end of the school year – Focusing on summer programming to recover unfinished learning in core subjects like math and reading, provide social-emotional supports and jump-start the 2021-22 school year
- June and July 2021 – Focusing on academic and social-emotional supports for a successful start to next school year
- Aug. 2021 and continuing as needs are identified – Focusing on academic and social-emotional supports during the 2021-22 school year and beyond

The first of these initiatives is expected before the end of the school year. Additional initiatives will be released in the coming months.

Oklahomans remain steadfast in their commitment to every student's right to a strong, well-rounded public education. The *Ready Together Oklahoma* plan provides a roadmap for how to leverage pandemic relief resources in ways that benefit students and their futures.

ARPA Supplemental Awards

Community Based Child Abuse Prevention Grant (CBCAP)

- To support community-based efforts to develop, operate, expand, enhance, and coordinate initiatives, programs, and activities to prevent child abuse and neglect and to support the coordination of resources and activities to better strengthen and support families to reduce the likelihood of child abuse and neglect
- To foster understanding, appreciation, and knowledge of diverse populations in order to effectively prevent and treat child abuse and neglect.
- Authorized by Title II of the Child Abuse Prevention and Treatment Act (CAPTA)

Maternal, Infant and Early Childhood Home Visiting Grant (MIECHV)

- The purpose of this program is to support the delivery of coordinated and comprehensive high-quality and voluntary early childhood home visiting services to eligible families.
- Strengthen and improve the programs and activities carried out under Title V of the Social Security Act;
- Improve coordination of services within at-risk communities;
- Identify and provide comprehensive services to improve outcomes for eligible families living in at-risk communities.



Community Based Child Abuse Prevention Grant (CBCAP)

FFY 2021 Appropriations

Regular Appropriation

- Consolidated Appropriations Act, 2021 (12/27/2020) made available \$60,660,00 for the CBCAP program.
- Oklahoma's award is \$503,100 (base amount). Period of Availability is 10/1/2020 to 9/30/2023.
- This represents 70% of our total award and is allotted proportionately among states based on the number of children under age 18 residing in each state.
- 30% of the total allotment is based on leveraging of non-federal funds (private, state, or other non-federal funds) identified by the awarded agency.
- OSDH leverages state, millage and fee supported programs such as home visiting programs including Children First and Parents-As-Teachers; Child Guidance, Heirloom Birth Certificates.

ARPA Supplemental Award

- ARPA provides \$250 million in supplemental funding for CBCAP.
- One percent is set aside for Indian Tribes and Tribal organizations and migrant programs; and continued funding for program support including funding for the National Center for CBCAP.
- Oklahoma's supplemental award is \$3,176,094. Period of Availability is 10/1/2020 to 9/30/2025.
- ARPA provides that 100% of the supplemental funds awarded by formula to state lead agencies for the CBCAP program will be allotted proportionately based on the number of children under age 18 residing in each states.
- Grants will be awarded to existing CBCAP grantees.
- No separate application is required to receive funding.



CBCAP Program Use of Funds

Developing, operating, expanding, and enhancing community-based, and prevention focused programs and activities designed to strengthen and support families to prevent child abuse and neglect that are accessible, effective, and culturally appropriate, and build upon existing strengths that:

- Offer assistance to families;
- Provide early, comprehensive support for parents;
- Promote the development of parenting skills;
- Increase family stability;
- Improve family access to resources in communities;
- Support needs of families with children with disabilities;
- Involving parents in program planning and implementation;
- Provide referrals to early health & development services.



CBCAP Program Use of Funds



Fostering the development of a continuum of preventive services for children and families, including unaccompanied homeless youth, through state and community-based collaborations and partnerships, both public and private.



CBCAP Program Use of Funds

Financing the start-up, maintenance, expansion, or redesign of specific family resource and support program community-based child abuse and neglect prevention program services. Identified as an unmet need, and integrated with the network of community-based family resource and support child abuse and neglect prevention program to the extent practicable given funding levels and community priorities;



CBCAP Program Use of Funds

Maximizing funding through leveraging of funds for the financing, planning, community mobilization, collaboration, assessment, information and referral, startup, training and technical assistance, information management and reporting, reporting and evaluation costs for establishing, operating, or expanding community-based and prevention-focused programs and activities designed to strengthen and support families to prevent child abuse and neglect.



CBCAP Program Use of Funds



Financing public information activities that focus on the healthy and positive development of parents and children and promotion of child abuse and neglect prevention activities.



Oklahoma's ARPA CBCAP Plan

1. Continued collaboration with partners to expand and enhance current projects, and develop new initiatives.
2. Release opportunities for funding through the RFP process for the development of Family Resource Centers which will be part of the National Family Support Network.
3. Additionally, offer funding opportunities for community child abuse and neglect prevention projects through an RFP process. This opportunity will be available to community organizations who wish to develop, expand or enhance projects that meet the requirements outlined in CAPTA for the use of CBCAP funding.
4. The bi-annual meeting for the *Oklahoma State Plan for Child Abuse and Neglect Prevention*, will be utilized as the entity to provide input on the CBCAP plan.



Maternal, Infant, and Early Childhood Home Visiting Grant (MIECHV)

FFY 2021 Appropriations

Regular Appropriation

- Consolidated Appropriations Act, 2021 (12/27/2020) made available up to \$342 million for MIECHV Formula Grants.
- FFY 2021 OSDH is eligible to request up to \$6,635,887. Period of Availability is 9/30/2021 to 9/29/2023 (2 years).
- This application is due June 30, 2021.
- There is no cost sharing/match required.

ARPA Supplemental Award

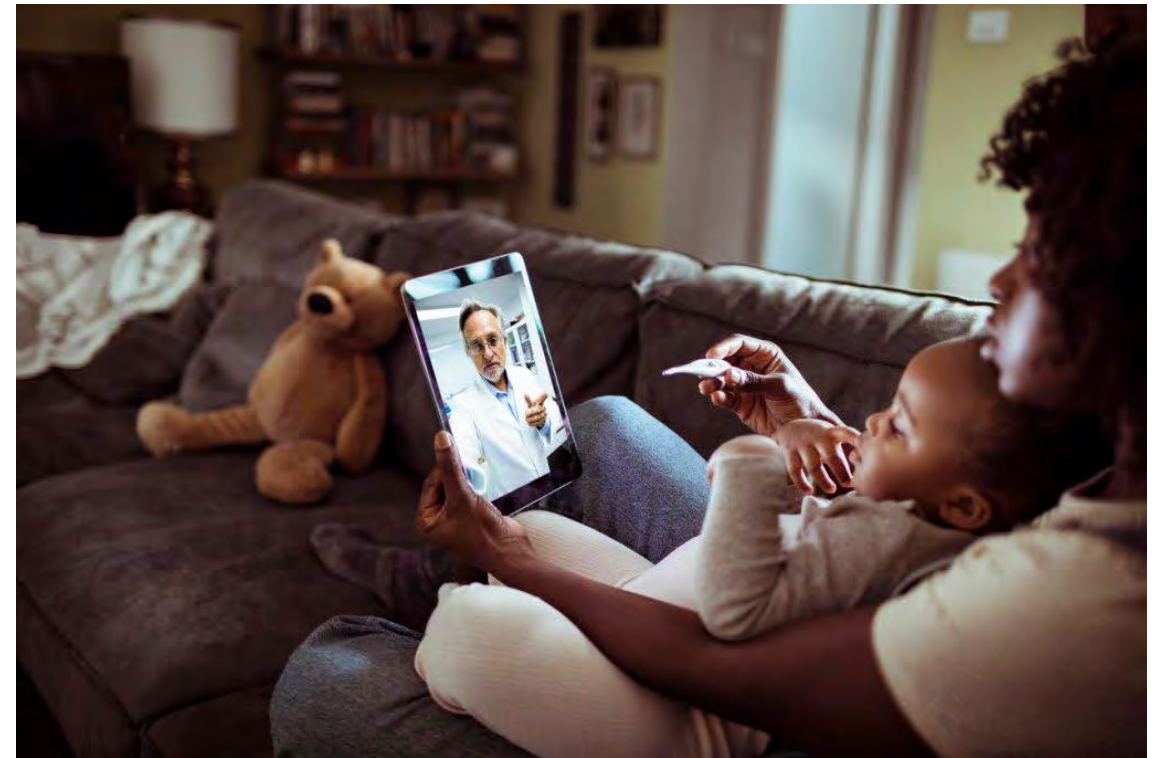
- ARPA provides \$150 million in supplemental funding for MIECHV.
- During round one of supplemental funding HRSA is making available \$40 million. Oklahoma is eligible to request \$745,397. Period of availability is 5/1/2021 to 9/30/2023.
- This is one-time funding and will be awarded to existing MIECHV grantees to address the needs of expectant parents and families with young children during the COVID-19 public health emergency.
- A separate application is required to receive funding, the application is due June 2, 2021.



MIECHV Program Use of Funds

Funds may be used to serve families with eligible service delivery model(s) to provide in-person or virtual home visits and other program activities. This includes service expansion to new families and/or new at-risk communities, as identified in your current statewide needs assessment update.

Acquire the necessary technological means, for families enrolled in the program, to conduct and support virtual home visiting

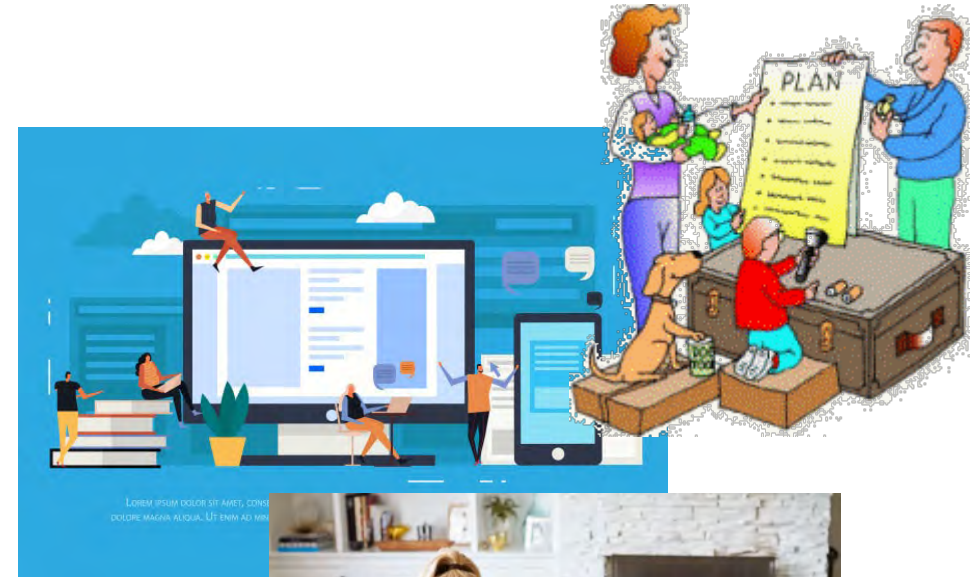

MIECHV Program Use of Funds

Funds may be used to develop, conduct, and evaluate training of home visitors that are employed by the recipient in:

- Conducting a virtual home visit;
- emergency preparedness and response planning for families;
- safely conducting intimate partner violence screenings;
- or safety and planning for families served to improve family outcomes in the MIECHV benchmark areas



MIECHV Program Use of Funds



To provide emergency supplies (such as diapers and diapering supplies including diaper wipes and diaper cream, necessary to ensure that a child using a diaper is properly cleaned and protected from diaper rash, formula, food, water, hand soap and hand sanitizer) to an eligible family.



To coordinate with and provide reimbursement for supplies to diaper banks when using such entities to provide emergency supplies



MIECHV Program Use of Funds

To provide prepaid grocery cards to an eligible family participating in the maternal, infant, and early childhood home visiting program for the purpose of enabling the family to meet the emergency needs of the family.



Under ARPA

- Recipients must ensure the modification of any grants, contracts, and other agreements with LIAs/sub recipients as necessary to ensure that during the project period, recipients will not reduce funding for, or staffing levels of, local programs on account of reduced enrollment in the program.
- Recipients must ensure coordination with local diaper banks when using funds to provide emergency supplies to eligible families, to the extent practicable.
- Recipients must reaffirm that, in conducting the program, the recipient will focus on priority populations

PRIORITY POPULATIONS

- Eligible families who reside in communities in need of such services, as identified in the statewide needs assessment;
- Low-income eligible families;
- Eligible families with pregnant women who have not attained age 21;
- Eligible families that have a history of child abuse or neglect or have had interactions with child welfare services;
- Eligible families that have a history of substance abuse or need substance abuse treatment;
- Eligible families that have users of tobacco products in the home;
- Eligible families that are or have children with low student achievement;
- Eligible families with children with developmental delays or disabilities; and
- Eligible families that include individuals who are serving or formerly served in the Armed Forces.

American Rescue Plan Act (ARPA) / Child Well-Being Snapshot

The American Rescue Plan Act of 2021 (ARPA), signed into law in March 2021, builds on previous pandemic relief efforts. ARPA is designed to provide aid to states, localities, territories, and tribes to fill revenue holes, address COVID-related needs, and address the learning needs of students.

The hardships caused by the pandemic harms not just individuals, but the potential of an entire generation. The intense stress caused by the pandemic can interfere with parenting and negatively impact a child's physical and mental health. Additionally, ARPA restores and expands the paid sick and family leave benefits that were passed in 2020. The clock was reset on March 31, 2021, so that those who took leave in the past year are eligible to take it again if needed.

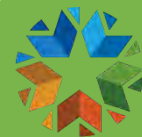

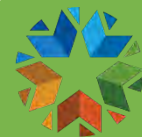
- a. identify and establish outcomes, goals and priorities for services for children and youth, including homeless children and youth, and the estimated costs of implementing such goals and priorities,

- e. be distributed as provided by paragraph 1 of this section and shall be made available to the general public.

OCCY COMMISSION MEETING
MAY 21, 2021**

PERSONNEL

Ful-time Employee: The Freestanding Multidisciplinary Team Training Coordinator position is now vacant.

Temporary Employee: No changes.

Contract Employees: We have contracted with the University of Oklahoma for the services of Dr. Mary Stockett. She will be serving as the State's Chief Child Abuse Examiner. She will be working with the Board of Child Abuse Examiners to recruit and train health care providers to serve in the child abuse network. In addition, Dr. Stockett will be providing child death reviews to aid in child abuse/neglect and criminal investigations.

Part-time Employees: Penny Hill-Malone retired from OCCY for the second time. She has been a long-time valued and trusted OCCY employee for many years. About two years ago, she returned to OCCY to work within the Office of Juvenile System Oversight. We appreciate all of dedicated service to us and the state.

FINANCES

General Budget Monitoring: Monthly finance meetings with the Office of Management and Enterprise Services (OMES) and OCCY staff continue. ***Please see the attached report.***

Certified Purchasing Officer: We are pleased to announce that Ms. Megan Lisenbee, our financial liaison with OMES, is now a Certified Purchasing Officer.

Potential State Fiscal Year 2022 Budget: We are anticipating that we will receive the additional funding requested in our recent budget request, \$214,000. This amount will allow us to hire one additional staff position for the Office of Juvenile System Oversight; one additional staff position for Child Death Review Board; and one additional staff person for the Office of Planning & Coordination.

DIRECTOR'S HIGHLIGHTED ACTIVITIES

OCCY Database: We began working with the Office of Management and Enterprise Services (OMES) in January to find a vendor that could build an over-arching database for OCCY. OMES presented us with three vendor options and the cost estimates varied widely. For that reason, we began to ask questions of the vendors' subject matter expertise, the scope of work included in the cost estimates, and the hosting/maintenance capabilities of the vendors. We had hoped to have had the project well underway at this point, but we are not. We hope to have a decision made about a vendor by early next week.

Infrastructure Work: We have begun our work with Dr. Mike Stout of Oklahoma State University on mission and vision statements as well as logic models for the agency and each of the departments. In addition, staff from OKDHS are assisting OCCY staff as they “process map” their daily efforts and look for efficiencies.

Staff Retreat: I want to thank Keith Pirtle and Ellen Lohrenz for planning a staff retreat for us at the University of Central Oklahoma. It will be a day dedicated to outdoor activities and team building in late August.

Step Challenge: I also want to thank Cherra Taylor for organizing a month-long step challenge for employees. Every day at 10:00am and 2:00pm she has assured that a quick, energetic one-mile walk video was playing for those in the office and those at home. Elizabeth Kaup was the winner of this challenge with 252,112 steps in April, but in some way we are all winners. Cherra continues to encourage us to take a step break and move more throughout the day.

OCCY PROGRAM HIGHLIGHTS

Post Adjudication Review Board - PARB (Keith Pirtle)

PARB Database: The University of Oklahoma’s E-Team (Evaluation Team) trained OCCY staff on the newly created PARB database. Staff were able to provide end-user feedback and PARB is now waiting for modifications to be made. This database will allow PARB members to enter information about the cases they review into one centralized database and perhaps make their recommendations to the Court via a digitized process. We anticipate that the database will be released for all PARB members use sometime early this summer.

Subcommittee Work: The State PARB has created a subcommittee to explore the specific health, welfare, and safety concerns of children who are isolated from their communities – particularly children that receive governmental services/supports and have been removed from school. Much like the task force researching the “deaths and nears deaths of children with special needs,” this subcommittee is striving to develop strategies that will identify children that may no longer be out in public settings and we worry they may be neglected.
