PERSONNEL

New Employee: Thanks to our partnership with the Oklahoma Partnership for School Readiness, we have brought on Ms. Caitlin Merritt to serve in the role of Community Planner for Oklahoma's federal Preschool Development Grant. Ms. Merritt's work will focus on improving early childhood education and outcomes by building community capacity and utilizing family-centered approaches. Prior to serving at OCCY, Ms. Merritt was a public educator for four years at the elementary level, focusing on equitable reading instruction and parent partnerships. She holds a bachelor's degree in Elementary Education from Cameron University and is a first-generation high school and college graduate. Her passion for serving single-parent households and neurodivergent families stems from her lived experience and belief that knowledge is transformative. Welcome Caitlin!

FINANCES (Mahboob ul Haq, OCCY Business Manager)

General Budget Monitoring:

Mr. ul Haq continues to monitor our current budget situation. DIRECTOR'S HIGHLIGHTED ACTIVITIES

The Impact of Medical Marijuana on Children Work Group:

This work group continues to meet and share information. A retreat is planned for August to solidify recommendations. We are anticipating working with Dr. Jeff Linkenbach, Director and Chief Research Scientist at the Montana Institute. Dr. Linkenbach has developed national award-winning programs that change community norms. He holds a doctorate of education with a focus on community education, a master's degree in counseling and has over the past 30 years of experience in public health leadership. He is known for translating social norms science into practical applications.

Commissioner Retreat:

While Dr. Linkenbach is here, we would like to incorporate his expertise into our OCCY Commissioner Retreat scheduled for August 18th. We have several meetings set up with Dr. Linkenbach over the course of the summer and will continue to seek your input as we craft the Commissioner Retreat agenda.

OCCY PROGRAM HIGHLIGHTS

Post Adjudicated Review Board – PARB (Keith Pirtle)

New PARB Established:

Mr. Pirtle is pleased to announce that the Muskogee County PARB held their first meeting on May 18th. All 10 members were present along with child welfare staff. We look forward to their good work.

In addition, Malayna Hasmanis, the Tulsa County PARB Coordinator, is working to develop two new Tulsa PARBs with specific focuses: 1) mental health, and 2) domestic violence. Office of Planning and Coordination - P&C (Danielle Dill)

Children of Incarcerated Parents (CIP):

- Big Brothers Big Sisters of Oklahoma (BBBSOK) was awarded \$75,000 for State Fiscal Year 2024 for the Oklahoma Mentoring Children of Incarcerated Parents Program. The award will support one-to one mentoring for 50 children in the state impacted by parental incarceration.
- CIP Advisory Committee Strategic Planning Meetings were held on May 12th at the Girl Scouts of Eastern Oklahoma office in Tulsa and June 9th at the OCCY office. The planning session was facilitated by the Restorative Justice Institute of Oklahoma and Fancy Hippie Group. They utilized the ABC(2) Framework Align, Build, Collaborate, and Communicate to guide the sessions and develop the plan.

Homeless Children and Youth:

- On May 2nd, Governor Stitt signed into law House Bill 1029, authored by Representative John Talley and Senator Brenda Stanley. It will go into effect November 1, 2023. This new law directs the Oklahoma State Department of Education (OSDE), in conjunction with the OCCY Homeless Children and Youth Steering Committee, to adopt a standard form to be used by all school districts which will identify students who are homeless. School districts are also required to report the results to the OSDE no later than June 1st of each year. Then, beginning July 1, 2024, and every year after, the OSDE shall compile a report containing the number of students who are homeless by district and grade level.
- OCCY, along with the Oklahoma Department of Mental Health and Substance Abuse Services, co-sponsored the "Family and Natural Support Training" May 22nd- 25th in Oklahoma City. This Canadian framework introduces and provides a preventive approach to addressing youth homelessness instead of simply providing emergency services

Parent Partnership Board (PPB):

- OCCY hosted the Children's Trust Fund Alliance (CTFA) "Bringing the Protective Factors Framework to Life in Youth Work" Training-of-Trainers April 18th – 20th at the Hilton Garden Inn & Edmond Conference Center. There were 20 attendees and the evaluation feedback was extremely positive. OCCY staff Isabel Rodriguez and James Boykin successfully completed the training along with Commissioner John Schneider.
- The PPB convened its first Retreat and Strategic Planning Session at the University of Central Oklahoma Boathouse on April 29th. The retreat included a myriad of activities

- including team building exercises and was facilitated by Chris Payne, APR with Union Public Schools.
- The partnership with the Oklahoma State Department of Health (OSDH) continues to
 move parent voice work forward through the Oklahoma Community of Practice (CoP):
 Developing and Sustaining Effective Parent Advisory Committees. The CoP featured
 the work of OCCY PPB Co-Chair Dr. Lana Turner-Addison as well as CTFA consultants
 Michael Huesca (California) and Kara Georgi (New York). A provider café was also
 conducted. Fifteen individuals representing 12 different organizations attended.
- In addition to the Community of Practice, OCCY is co-sponsoring the OSDH Family Support and Prevention Service annual meeting on June 27th. OCCY PPB member Senaqua Hildreth will share her expertise at the meeting by serving on the parent voice panel. OCCY PPB will also be staffing a resource table at the event.

State Plan Partnerships:

- OCCY co-sponsored along with ODSH and the Oklahoma Human Services (OKDHS) of the 6th Annual Biannual Collaborative Convening on April 5th. OCCY staff served as small group facilitators for the parent and youth voice session as well as the engagement in policy and practice session. OCCY PPB member Nubia Fiesel shared her lived expertise at the event. There were approximately 100 participants.
- The OSDH, OKDHS, and OCCY are working together to support each agency's state plans. Recently, an electronic survey was distributed among families and professionals asking about supports needed in their communities. The survey closed May 15th with over 1000 responses – with at least one response coming in from each of the 77 counties
- Planning has gotten underway to conduct in-person and virtual community cafés. These
 cafés are a series of conversations planned and led by family members who learn the
 Community Café approach, so that participants can relate to each other and build
 community assets. The approach incorporates hosting principles, Appreciative Inquiry,
 and the Protective Factors needed to strengthen families. The first café is scheduled for
 July 11th in Norman. In addition, Isabel Rodriguez, OCCY Community Planner, will be
 conducting at least one community café in Spanish.

Strengthening Youth Custody and Transition Services

- The Mentoring Work Group met on April 27th and is exploring the idea of piloting *Mentoring Central's* online training for contracted mentors through the Office of Juvenile Affairs and other youth services organizations.
- The State Fiscal Year 2024 Memorandum of Understanding between OCCY, the Oklahoma Department of Rehabilitation Services, OJA and the Oklahoma Youth Academy Charter School (OYACS) is signed by all parties. This MOU provides paid work experiences for youth who are on track to be transitioned out of OJA custody at the Central Oklahoma Juvenile Center and attending the OYACS.

Miscellaneous:

 OCCY was pleased to sponsor a hole for the 2023 Oklahoma School for the Deaf Golf Tournament.

Legislative/Policy Issues (Marcia Johnson)

Ms. Johnson will present a legislative wrap up of legislation and rules pertinent to OCCY at the commission meeting. I want to thank Ms. Johnson for her efforts this past session. In addition, to tracking legislation, meeting with House and Senate members/staff, and keeping us all informed, she shepherded our rule changes. For those of you who may not know, the rules process is very specific and she did not miss a beat.

Freestanding Multidisciplinary Teams (FSMDT) (Brittany Gassner) FSMDT Database:

We so appreciate the work of Maggi Hutchason (Noble County), Lara Welch (Love County), and Amanda Wheeler (Murray County) for piloting the new FSMDT database. They have provided such useful feedback. With their help, the OU E-Team is on track to launch the new statewide database at the beginning of July 2023. For the first time since administering the FSMDT Program, OCCY will have an electronic, real-time data collection system to track and manage staffed cases.

Board of Child Abuse Examiners:

- On April 5th, a medical pre-institute was held at the Annual Oklahoma Conference on Child Abuse and Neglect. Seventy-five professionals attended this eight-hour session.
- Currently, OCCY has 16 Memorandums of Understanding with 16 child abuse examiners from across the state. Per statute, the contact information for these examiners has been distributed to OKDSH, local health departments, District Attorney offices, FSMDTs, and child advocacy centers.
- A Child Abuse Examiner Training, co-sponsored by HARUV USA and Child Advocacy Centers of Oklahoma, will be held this upcoming fall in Tulsa. Subject matters will include commercial sexual exploitation of children. The Oklahoma State Bureau of Investigations will provide an updated on the backlog of sexual assault kits.

Chief Child Abuse Examiner (Dr. Mary Stockett):

Dr. Stockett is in the process of training health care providers in Hooker, Henrietta, and Yukon to be child abuse examiners. Once they have satisfactorily completed the training, they will be added to the list of examiners and their contact information will be shared with the relevant parties.

Oklahoma Child Death Review Board - CDRB (Lisa Rhoades)

- During April, Ms. Rhoades met with Tracie Morris the Coordinator of the Cherokee National Grandparent Program Coordinator. The Cherokee Nation is considering becoming a partner with Preparing for a Lifetime, a collaborative group made up of professionals from varying organizations to possibly pilot the Grandparent Toolkit. The toolkit is designed to provide educate grandparents about current best practices related to children's safety and health.
- On May 6th, Ms. Rhoades participated in Safe Kids Day at the OKC Zoo and facilitated an interactive activity around booster seat requirements and usage for zoo patrons. In addition, caregivers were being recruited into a research study regarding harness-style car seat usage.

• Ms. Rhoades will be attending the Safe Kids World Wide Childhood Injury Prevention Convention in Washington, D.C. during July 23 – 26th. This convention brings together leading experts, advocates, academics, and partners to share best practices and experiences with the goal of increasing their collective impact. The National Center Fatality Review and Prevention will be paying for Ms. Rhoades' travel expenses.
