DIRECTOR'S REPORT OCCY COMMISSION MEETING April 11, 2025

PERSONNEL

<u>Child Death Review Board</u>: OCCY is pleased to have been provided state appropriations for a new CDRB employee – an Injury Prevention Coordinator. This position will serve as part case-manager AND as an educator. We envision this position providing schools, youth groups, civic organizations, parenting classes, etc. the latest information on how to keep children and youth safe and alive. Topics for presentations can include safe sleep practices, car seat safety, abusive head trauma prevention, and more. Interviews are being conducted now and the position should be easily filled by the beginning of next month.

DIRECTOR'S HIGHLIGHTED ACTIVITIES

<u>Grand Jury Petitions Filed</u>: None of the three previous grand jury petitions obtained enough signatures to proceed. However, a new petition was filed in Garfield County. No one from OCCY is listed on that petition.

Return to Office: OCCY is complying with Governor Stitt's Executive Order 2024-29 as best as we can. When we moved to our current office location, we downsized as was suggested. Approximately half of our office worked from home full-time and generally came in only for monthly all-staff meetings. However, we now have all staff in the office at least once a week.

We are exploring the possibility of expanding our office space within the Cameron Building and on the third floor. The building manager and the realty section of the Office of Management and Enterprise Services are in contact and we will keep you abreast. We do not have funds to expand and accommodate all staff, but some expansion would alleviate some congestion.

<u>Tour of Central Oklahoma Juvenile Center (COJC)</u>: I want to thank Director Tardibono for allowing me to tour COJC and more importantly attend the Home Sessions with the young men. It was inspiring to see the Office of Juvenile Affairs home program in action.

PROGRAM HIGHLIGHTS

Child Death Review Board (CDRB) - Lizz Kaup, Program Manager

<u>Annual Report</u>: A draft of the Annual Report utilizing the complete data from deaths that occurred in that year has been submitted by the OU E-Team for OCCY review and editing. This report will be the first in many years that includes data from only one specific year. We will use 2022 report to set our baseline and identify trends.

Indian Child Welfare in Tulsa County: Tulsa County PARB Coordinator Malayna Hasmanis hosted a quarterly Indian Child Welfare Act Coffee Chat. Attendees shared insights and discussed best practices. They are considering hosting similar events across the state. The April Coffee Chat will focus on "active efforts."

Office of Planning and Coordination (P&C) – Danielle Dill, Program Manager
Parent Leadership Awards: OCCY will be participating in the Child Abuse Prevention Day at the Capitol on April 30th and presenting Parent Leadership Awards. We had many outstanding nominees this year and look forward to recognizing this year's winners.

<u>Parent Advisory Training</u>: In March, OCCY hosted the National Family Support Network Parent Voices Matter: Cultivating Resilient Parent Advisory Committees Virtual Training. The training was a rousing success with 33 attendees.

The Child Abuse Training and Coordination Council (CATCC): A meeting was held in
February. Ms. Pat Damron, former Program Coordinator at the Oklahoma State Department

for May 27th at 10:00am.
