#### DIRECTOR'S REPORT OCCY COMMISSION MEETING June 20, 2025

#### **PERSONNEL**

<u>Child Death Review Board</u>: We have a vacancy in Child Death Review Board. The position was filled for a short time, but we ultimately lost the new employee for a better paying position at the Oklahoma Office of the Attorney General. Due to budget constraints, we will more than likely wait a bit to refill it. It is a new position for us. The position will serve as a part-time case manager and an injury prevention specialist/education. The position will share information gathered during CDRB (in aggregate and de-identified) in the form of presentations, offer educational presentations to children about how to keep infants, children, youth and themselves safe. This position will also be charged with working with partners to improve policies, practices and perhaps laws to prevent child deaths.

CDRB also has two new, paid graduate interns:

- Mr. Andrew Long is an Ophthalmic Technician, Medical Scribe, and Surgical
  Technician turned full-time graduate student. He is pursuing a Masters in Public Health
  at the University of Oklahoma Health Science Center with an emphasis on epidemiology.
- Ms. Vivian Sanchez is a graduate student seeking a Masters in Public Health at the University of Oklahoma Health Science Center. She has most recently served as a Graduate Research Assistant focusing her efforts on combatting health advertising of tobacco. In addition, she has served as an interviewer for the Oklahoma State Department of Health Behavior Risk Factor Surveillance System and as an Epidemiology Intern at the Waco-McLennan County Health Department.

#### FINANCES - Mahboob ul Haq, OCCY Business Manager

#### **General Budget Monitoring:**

Mr. ul Haq continues to monitor our current budget situation. In addition to the attached report, Mr. ul Haq will present information during our meeting that will provide further explanation and detail. (*Please see handout*.)

#### State Fiscal Year 2026 Budget:

Grand Jury Petitions Filed: At this time no new grand jury petitions have been filed that include Annette Wisk Jacobi or other OCCY employees as subjects.

Office Expansion: Due to lack of available funding, OCCY will not be seeking additional office space. For this reason, we will continue to have all those who were teleworking only come into the office once a week and utilize the commuter spaces.

<u>Tour of Central Oklahoma Juvenile Center (COJC)</u>: I want to thank Director Tardibono for allowing me to tour COJC and more importantly attend the Home Sessions with the young men. It was inspiring to see the Office of Juvenile Affairs home program in action.

<sup>\*</sup>Natural death cases eligible for review include deaths in which abuse or neglect was a component of the case. For example, the child died of asthma and the caregivers had a history of not obtaining medical treatment for the decedent.

At the end of calendar year 2023, OCCY Leadership and CDRB made the decision to 'skip' ahead to focus on 2022 deaths and near deaths. The goal is to review and close, including completing data entry on, all 2022 cases and produce an annual report comprising of 2022 data. Once 2022 is complete, the goal will be to continue moving forward to 2023 cases while also catching up the 2020 and 2021 cases.

#### Postadjudication Review Board (PARB) - Keith Pirtle, Program Manager

New Atoka County PARB: The first meeting of the Atoka County PARB was held on May 7<sup>th</sup>. Mr. Pirtle facilitated the meeting and three, newly-trained PARB members began reviewing cases.

<u>State PARB</u>: The State PARB meeting took place on May 16. Sarah Sarah Herrian was elected as the new State PARB Chair. In addition, three members were nominated for submission to the Governor's Office to serve as the State PARB representatives to the Commission. These nominees include Dr. Kalie Kerth, Cindy Nocton and Daniel Herring.

<u>PARB and Parent Voice</u>: Oklahoma County PARB Coordinator Ms. Shelbi Tartairan facilitated the final session of the Bi-Monthly Parent Voice Series. This series has been instrumental in helping PARB members develop a deeper understanding of the parent experience, thereby improving the quality of board recommendations.

New Tulsa PARB Coordinator: Ms. Malayna Hasmanis provided her notice of resignation during May. She has been a transformative coordinator and her energy has been infectious. However, we are pleased to say that Ms. Saralyn Miller has taken on the role and has hit the ground running.

## Office of Planning and Coordination (P&C) – Danielle Dill, Program Manager Children of Incarcerated Parents (CIP) Partnership:

The Children of Incarcerated Parents Advisory Committee convened on May 9 and established CIP Advisory Workgroups based on 25-26 strategic plan: 1) Networking and Respite for Service Providers; 2) CIP Advocacy Day at the Capitol; and 3) Data Mapping.

In addition, their service provider event will be a partnership between OCCY, Haruv USA, and the OU Anne and Henry Zarrow School of Social Work. It is scheduled for November 14, 2025 in Tulsa.

#### Homeless Children & Youth (HCY) Partnership

Although supported by both chambers of the legislature, Senate Bill 799l was vetoed by the Governor on May 22<sup>nd</sup>. He cited issues with parental control and concerns of abuse for his rationale.

Oklahoma Partnership for School Readiness Preschool Development Grant (PDG) Partnership The annual OCCY PDG site visit/audit was conducted by staff from the OPSR on May 8<sup>th</sup>. No issues or concerns were cited. In addition, the Early Childhood Transition Summit, sponsored by OCCY, is scheduled for June 20-21. The event is sold out.
