OCCY Parent Partnership Board (PPB) Report

- Mitch Sutter shared his personal experiences overcoming substance abuse and

rebuilding family life. Highlights included:

- Emphasized the role of collaboration among judicial systems, law enforcement, treatment providers, and community organizations.
 - Commissioners commended Mitch Sutter's advocacy work.

Presentation and Approval of OCCY Finance Report

– *Mahboob ul Haq, OCCY Business Manager*

- Mr. ul Haq provided updates on financial status, including budget utilization and cash balances.
 - Commissioner Cartmell moved to approve the OCCY finance report. Commissioner Warren seconded the motion. All members present voted in the affirmative. The motion passed.

Presentation: Oklahoma's Credit Union and OCCY Youth Banking Partnership

– *Tammy Killman, AVP Member Experience, Oklahoma's Credit Union*

Tammy Killman's presentation highlights included:

- Over 50 accounts have been opened for youth transitioning into adulthood, along with financial literacy education.
 - The credit union is opening accounts for youth with an initial \$5 deposit at no cost to the youth and waiving the \$25 checking account fee.
 - Commissioners expressed strong appreciation for the credit union's commitment.

Formal Adoption of Oklahoma Commission on Children and Youth Rule Changes

By Oklahoma Commission on Children and Youth Commissioners

– *Marcia Johnson, OCCY Legislative Liaison*

Highlights from the presentation included:

- The proposed rule amendments clarify the authority of the Oklahoma Commission on Children and Youth with respect to approving and monitoring freestanding multidisciplinary child abuse teams. The proposed amendments add definitions and provide procedures for annual reviews and site visits incorporating peer reviews to determine the functioning of freestanding multidisciplinary teams. The proposed amendments clarify the collection of freestanding multidisciplinary team data, including

- individual responsibilities and the use of a secure database.
- According to Assistant Attorney General Sandra Balzer, this agenda item complies with the Open Meetings Act.
 - During the January 17, 2025, public hearing, OCCY staff did not engage with the two speakers who represented Child Advocacy Centers.
 - Commissioners requested more time to review in the future.
 - Commissioner Warren moved to approve the rule changes. Commissioner Aaron seconded the motion. Judge Warren, District Attorney Hicks and Commissioners Aaron, Schneider, Hall and Kerth voted in the affirmative. Director Cartmell, Commissioner Reed and CEO Buettner voted to abstain. The motion passed.

Presentation: Legislative Update

– *Marcia Johnson, OCCY Legislative Liaison*

Marcia Johnson presented a legislative update, highlights and key bills, including:

- HB1574 restores the ability of OJSO to make routine inspections of privately operated children and youth facilities that receive state/federal funding.
 - HB1581 would move the administration of FSMDTs from OCCY to an entity “identified as a nationally accredited association of Children’s Advocacy Centers.” All the funds appropriated by the legislature into the Child Abuse Multidisciplinary Account, which is passed through Oklahoma Human Services, would go to this accredited association.
 - HB1863 clarifies the duties of FSMDTs and requires that the teams utilize a secure database for entering case review information.
 - HB2892 clarifies the authority of the Executive Director of OCCY to request an investigation of certain cases by OSBI.

Presentation of a Resolution Celebrating the Legacy of Dr. Stephen Grissom

– *Chairperson John Schneider, OCCY Commission Chairperson*

- Mark James, Assistant Director for OCCY, recognized Dr. Grissom’s contributions to juvenile justice. Dr. Grissom passed away on January 10, 2025. Dr. Grissom was a pioneer in Oklahoma’s juvenile justice system. Dr. Grissom developed and implemented behavioral treatment programs throughout the state’s juvenile training schools. Mark James worked with Dr. Grissom for over 30 years at one Office of Juvenile Affairs (OJA) facility. In recognition of Dr. Grissom’s decades of service, OCCY prepared a formal Resolution of Remembrance for Dr. Grissom.
 - Commissioner Reed moved to approve the Resolution for Dr. Stephen Grissom. Judge Warren seconded the motion. All members present voted in the affirmative. The motion passed.

 - She asked that commissioners sign a card for Dr. Bob Block as he is in hospice care. Dr. Block was Oklahoma's first board-certified Chief Child Abuse Examiner and participated for many years on Oklahoma's Child Death Review Board. His contributions to child abuse prevention and treatment in this state and nation are significant.

Highlights of Activities and Outputs

Background

In 2019, the Children's Endowment Fund of Oklahoma was created in statute. The funds are to be administered by the Oklahoma Commission on Children and Youth (OCCY), at the direction of the OCCY Commissioners, through a grant process to "stimulate a broad range of innovative programs, activities or research or evaluation that will improve the well-being and reduce the adverse childhood experiences of Oklahoma's children." Professionals in the social service sector increasingly recognize the importance of the consumer's voice in decision-making at the individual, local, state, and national levels to improve policy and practice. For that reason, when the Children's Endowment Fund was enacted, also established was the OCCY Parent Partnership Board (PPB). The PPB aims to connect individuals with lived experiences with OCCY Commissioners to advise the Commissioners and the agency in its effort to improve Oklahoma's child-serving systems.

Activities and Outputs

The OCCY Parent Partnership Board (PPB) has actively engaged in numerous initiatives to advise child-serving agencies and advocate for families and children across Oklahoma. From participating in conferences, presenting on panels, and organizing community meetings and workshops, PPB members have demonstrated their unwavering commitment to enhancing family well-being and promoting effective parent leadership. Their efforts have not only brought awareness to critical issues but also provided tangible support and resources to those in need, embodying the core values of OCCY and making a significant impact on their communities.

- On January 29th, 30th, and February 3rd, new PPB members Colleen Howe, Dena Drabek, Cierra White and PPB Chair James Ray participated in the Oklahoma Institute for Child Advocacy (OICA) Legislative Learning Lab. This intensive program provides a deep dive into the Oklahoma legislative process, equipping attendees with valuable knowledge and insights to enhance their advocacy and leadership efforts.
- OCCY PPB Chair James Ray completed the Children's Trust Fund Alliance Bringing the Protective Factors Framework to Life in Your Work Training of Trainers, February 3rd to 6th. The training is

grounded in the Strengthening Families™ Protective Factors Framework and is intended for individuals who want to train and facilitate gatherings to help families build protective factors that create strong families, promote optimal child development, and reduce the likelihood of child abuse and neglect.

- On February 13th, OCCY, Oklahoma State Department of Health, and Oklahoma Family Support Network hosted the Oklahoma Community of Practice (CoP): Developing and Sustaining Effective Parent Advisory Committees and Family Engagement. This initiative equips professionals with strategies and tools to foster strong staff-parent leadership, promoting a shared identity and collective intelligence that enhances both new and existing Parent Advisory Committees. The session featured Kara Georgi, Lead Senior Associate, Children's Trust Fund Alliance, who shared valuable resources for celebrating Parent Leadership Month and facilitating productive meetings. The event brought together 38 attendees from various organizations across the state, strengthening collaboration and advancing family engagement efforts.
- On February 25th, OCCY PPB members, in partnership with the Oklahoma Partnership for School Readiness Foundation, hosted a successful Legislative Breakfast at the Oklahoma State Capitol. This event provided a valuable opportunity for PPB members and legislators to connect, reinforcing the importance of collaborating with parents to shape policy and practice. It also served as a platform to celebrate National Parent Leadership Month, recognizing the vital role parents play in influencing policies that impact families and communities.
- OCCY PPB member Mitch Sutter joined the Children's Trust Fund Alliance Birth Parent National Network (BPNN) webinars as a co-facilitator. The BPNN is dedicated to empowering birth parents as leaders and strategic partners in the prevention and child welfare system reform. The network actively recruits and engages parents who have experienced or are at risk of involvement in the child welfare system, as well as organizations that support them. The February session, themed "Celebrating the Stories that Strengthen Us," honored Parent Leadership Month, highlighting the powerful impact of parent voices in shaping policies.
- OCCY hosted the National Family Support Network Parent Voices Matter: Cultivating Resilient Parent Advisory Committees training, March 5th to 6th. This training equips staff with strategies and tools to enhance the effectiveness of Parent Advisory Committees (PACs), maximizing their impact on both parents and programs. A PAC is a leadership group composed of program participants who provide input, guidance, and feedback on a regular basis. When actively engaged, PACs serve as a powerful tool for fostering meaningful parent involvement, developing parent leadership skills, and contributing to a program's overall success.
- On March 11th, PPB members Alice Jeffrey and Chair James Ray continued their participation in the bi-monthly PARB Bio Parents Voice Series. This session focused on "Intertwined Struggles: Addressing the Dual Impact of Substance Use and Mental Health," highlighting the complex challenges families face and the importance of integrated support systems.
- On March 11th, PPB members Mitch Sutter, James Ray, and Alice Jeffrey presented at the Oklahoma Alliance for Recover Resources (OKARR) Peers: Navigating the Pathways of Recovery Resources

Conference. The session provided a parent perspective, offering valuable insights into the experiences, challenges, and strengths of parents navigating the recovery.

- OCCY PPB received 25 nominations for the 2025 Oklahoma Parent Leadership Awards. The program recognizes parent leaders who use their skills and talents to strengthen communities and positively impact on the lives of children and families across the state. This year's awardees are Marques S. Thomas from Garvin County, Yolanda Galloway from Tulsa County, and Erica Herrera from Oklahoma County. They will be honored in April in partnership with the Oklahoma State Department of Health and as part of the annual Child Abuse Prevention Awards.
- On April 2nd, PPB member James Ray shared his lived experience at the Oklahoma Human Services (OHS) Executive Team meeting, which consisted of approximately 25 agency leaders. His insights provided valuable perspective to the leadership team, reinforcing the importance of the agency's work.

Increase for Foster Care Payments

Key Provisions of HB2030

- House Bill 2030 increases the base foster care maintenance payment by \$5/per child/per day.
- **Flexibility for Increase:** Oklahoma Human Services (OHS) has the authority to approve foster care payments higher than the established minimums if child is in need of additional services.

Impact

- House Bill 2030 provides vital financial support to foster families and creates a system for continuous evaluation and adjustment, enhancing the quality of foster care and strengthening the well-being of children in Oklahoma's foster system.

Current Base Rate

- \$17-\$22 Per Day

Effective Date

- HB 2030 will become effective on November 1, 2025.

HB2030

Key Provisions of the Bill

\$5 daily increase per child, raising the base rate from \$17–\$22 to \$22–\$27 per day.

There are two possible approaches to implementing this change, each with its own fiscal impact:

- **Increase for foster children only (5900 Children):**
This adjustment would result in a \$3.9 million increase in state funding for foster children, supplemented by an additional \$6 million in matching federal funds.
- **Include both foster and adopted children (20,000 children):**
This approach would require an additional \$18 million in state funding, with \$28 million in matching federal funds.



HB2030 Talking Points

1. Foster children require greater financial support

Financial support for foster children is vital to ensuring they have access to basic necessities such as food, clothing, school supplies, and extracurricular activities that help them thrive. **The last increase occurred in 2018.** With inflation driving up the cost of everyday essentials, foster families are facing greater financial challenges while caring for vulnerable children. HB2030 addresses this issue by the base rate to reflect current economic realities, enabling foster parents to provide stable, nurturing homes without financial stress.

2. Economic Justification

Investing in foster care leads to long-term benefits for society by reducing costs associated with trauma, poor education outcomes, and involvement in the juvenile justice system.

3. Helps with Recruitment of Foster Homes

The foster care system is currently facing a crisis with a significant shortage of available foster homes to meet the growing demand. By increasing funding and resources, this bill seeks to encourage more families to become foster parents by providing them with the necessary support and financial stability. This will help alleviate the strain on the system and ensure that more children have access to safe and nurturing homes.

4. Alignment with Values

HB2030 reflects a commitment to compassion, responsibility, and prioritizing the welfare of children over less critical budgetary allocations.

OKLAHOMA SENATE BILL 364

End corporal punishment on students with disabilities

AUTHORS: Senator Dave Rader and Representative Anthony Moore

Prohibit the use of corporal punishment on students with disabilities as identified under the Individuals with Disabilities Education Act (IDEA).

Key Objective

School personnel would be prohibited from administering corporal punishment (CP)—including hitting, slapping, paddling, or any other method of inflicting pain—**on students with IDEA recognized disabilities.**

Student disabilities covered under Section 504 plans, defined by the Rehabilitation Act of 1973, are not included in this corporal punishment prohibition.

LEGISLATIVE ALIGNMENT

SB364 aligns with Oklahoma State Statute §70-18-109.5, which provides detailed definitions of each disability listed under IDEA.

IDEA Recognized Disabilities

- Autism
- Deaf-blindness
- Deafness
- Traumatic Brain Injury (TBI)
- Hearing impairment
- Intellectual disability
- Multiple disabilities
- Speech/ language impairment
- Emotional disturbance (e.g. schizophrenia)
- Visual impairment, including blindness
- Orthopedic impairment (e.g., poliomyelitis, cerebral palsy)
- Other health impairment (e.g., epilepsy, heart conditions)
- Specific learning disability (e.g., perceptual disabilities, developmental aphasia)

GUIDELINES

The description of the disabilities under each IDEA category covered by SB 364 is referred to in established state and federal guidelines, providing clear guidance to schools and educators.

A student with disabilities identified under IDEA requires specialized instruction and services to enable the child to learn. School professionals, specialists/therapists, and parents create an Individual Education Program with measurable learning goals and progress benchmarks.

- Children with disabilities are particularly vulnerable to corporal punishment. When students with disabilities are subjected to corporal punishment for behaviors associated with their disabilities, they are unjustly and excessively punished and deprived of access to quality education and a safe learning environment. ¹
- OK School Districts have access to student behavior management trainings at no cost such as BeST Behavior Training to increase the capacity of school staff to address significant student behavior and Multi-tiered System of Supports (MTSS) to help educators implement effective behavioral interventions and supports for students. ²

Legislator Concerns / Misunderstandings Related to SB 364 “Prohibit Use of Corporal Punishment to Discipline Students with Disabilities Under IDEA”

SB 364 Undermines Parental Rights.

This bill does not prohibit parents from administering corporal punishment at school on their child. In the state of OK, parent permission is not required to use CP on a student even a disabled student under IDEA except the "significant cognitively disabled student" which is a very small percentage (less than 10%) of disabled students in OK. In state statute, discipline policies are under the control of the local school districts, and the district decides whether to require parent permission to corporally punish a child. In “List of Example Cases of CP being administered to Disabled Students in OK Public Schools Document” except for the child with cerebral palsy and Indianola School District case, the parent did not give permission for their child to be corporally punished. And except in the cerebral palsy case, parents did not learn about the CP till their child told them or in the case of the non-verbal child, an adult that observed the CP reported. In one case above, the parent put a letter in the student’s file not to corporally punish their child and the child was paddled several times prior to the parent learning about the use of CP.

Corporal punishment (CP) of Students with Disabilities is Only Administered with a Paddle.

The legal definition in OK state statute describes it as hitting, slapping, paddling or any other method of inflicting pain. On the list of example cases document (slide presentation) there are confirmed cases where slapping, hitting, hair pulling, and choking were used to discipline a disabled student under IDEA in OK Public Schools.

Evidence CP of Students with Disabilities under IDEA Happening in OK Public Schools.

In the summer of 2022, State Department of Education Special Education conducted a survey regarding the use of CP on disabled students under IDEA in OK Public Schools. SDE SPED Survey Results - 63 school districts self-reported administering corporal punishment to students with disabilities under IDEA with a total of 455 incidences in the 2021-2022 school year. **And nine school districts included in the list of case examples document are not on the list of school districts self-reporting the use of CP on students with disabilities under IDEA in the summer of 2022.**

History – In March 2020, the OK State Board of Education approved the rule that prohibited the use of corporal punishment on students with disabilities entitled to special education services under IDEA beginning in the 2020-2021 school year. This rule was signed by Governor Stitt in June 2020. <https://www.edprofiles.info/doc/profiles/2022/reports/src/202248c072105.pdf>

A student Can Easily Qualify as Disabled under IDEA and Require an Individualized Education Program (IEP), in OK Public Schools.

Currently in OK only 17% of students qualify as disabled under IDEA. In the school year 2020-21 - 20% of all incidences of CP were on students with disabilities under IDEA. A student that is categorized disabled under IDEA **requires specially designed instruction and special services** (i.e. occupational therapy, physical therapy, behavior therapy, nursing, speech therapy, mental health therapy etc.) because their **disability adversely impacts their ability to learn.**

Examples of misunderstandings regarding specific IDEA disability categories -

- Vision or hearing impairment – when a student qualifies under IDEA, the student’s vision or hearing disability **cannot** be corrected by glasses or hearing aids (or cochlear implants). In both these impairment disabilities, specialized instruction and additional services or therapy is required for the child to see or hear.
- Dyslexia is another student disability under IDEA that is commonly misunderstood. Due to the Strong Readers Act, Universal Screening is done in public schools which screens for **characteristics of dyslexia but is not a diagnosis of dyslexia**. Characteristics of dyslexia may include slow word recognition or a problem with blended sounds but these students’ reading skills are within average range of those students who can read. So, these students with dyslexia characteristics **are not** eligible or qualified as disabled under IDEA but will benefit from reading intervention support. A student qualified with dyslexia under IDEA must be below 16% standardized norm reference test performed

by psychologist or psychologist. Additionally, they will have weekly monitoring of five reading components while participating in reading intervention. Data is collected and if progress is not seen after 6- 9 weeks of the reading intervention, the student can be referred for a learning disability under IDEA. **A student with dyslexia disability under IDEA is qualified because after a comprehensive evaluation, it is determined the severity of the dyslexia adversely impacts their ability to learn. A student with true dyslexia, has a neurological deficit that causes them not to be able to read with comprehension.** They may be on grade level recognizing letter sounds, reading words, and pronouncing words, but will always have a problem with reading comprehension and **require specialized instruction and special services to learn.**

Dr. Andrea Kunkel, general counsel for Cooperative Council for Oklahoma School Administration (CCOSA) and executive director for Oklahoma Directors of Special Services (ODSS), explained at the House Education Interim Study in 2023 that the process for identifying a child as qualified under the IDEA categories is a “very in-depth process”. A disabled student under IDEA has their IEP reviewed by school personnel and specialists several times a year and the IEP is continuously adjusted – which is not an “easy” process.

Prohibiting Use of CP to Discipline Students with Disabilities Undermines Teachers' Ability to Maintain Classroom Discipline and Alternative Methods of Discipline Training a Cost Burden to School Districts.

Research shows that positive behavior interventions are more effective in managing student behavior without the risks of trauma or legal liability associated with corporal punishment. Evidence-based alternative methods of discipline are cost-effective and already widely used in majority of OK Public Schools. And Federal IDEA funds can also be used to support cost of training in positive behavior strategies. Currently, SDE contracts with several state entities to provide alternative behavior/discipline training at **no cost** to districts and these trainings are offered multiple times during the year including summer such as the BeST behavior training at UCO Behavior Central.

Prohibiting the Use of CP to Discipline Students with Disabilities Creates Two Distinct Categories of Students – “those that can be paddled and those that cannot be”.

Disabled students under IDEA are already distinguished as a separate population in OK public schools. **They are afforded the right to have their differences recognized under federal law, and their differences are already accommodated in public schools so prohibiting CP would be no different.** The reasons not to use corporal punishment on disabled students under IDEA include

- Disabled students may not be able to control their behavior, as it is often a manifestation of their disability.
- May not cognitively understand why they're being punished, and CP could increase behavior issues and result in emotional trauma.
- Their disruptive behavior is a reaction to humiliation or bullying related to their disability.
- Physically not able to respond appropriately because of their disability (i.e. speech or sensory disorder)

The use of corporal punishment interferes with students' progress towards goals of positive behavior.

- Autism Foundation: “Corporal punishment is inappropriate for students with disabilities under IDEA because it ignores their lack of control over behavior, cognitive understanding, and physical limitations. It can worsen behavior, cause emotional trauma, and is often a response to bullying or humiliation related to their disability.”
- Parent Child Center Tulsa: "The distinction (between students) reflects a need for fairness, not privilege, recognizing that corporal punishment disproportionately harms disabled students due to their unique vulnerabilities."
- Dr. Scott Singleton, UCO professor, Board Certified Behavior Analyst and Nationally Certified School Psychologist “Students with disabilities, including speech/ language impairments, may not be able to process what they’ve done or why they’re being punished.” To summarize his Interim Study comments - The use of corporal punishment to discipline is ineffective because the disabled child (under IDEA) often cannot correlate why they are being hit with what they did.

The SB 364 Infringes on Local Control of Schools.

The bill aligns with federal guidelines under IDEA, which already establish protections for students with disabilities and ensures safe, equitable learning environments. **There are other statewide rules in public schools that are mandated under OK Statutes that local districts and parents do not control such as Compulsory Education (attendance) 70 OK Stat § 10-105.**


