STATE POST ADJUDICATION REVIEW ADVISORY BOARD MEETING MINUTES

Regular Meeting April 22, 2022 10:00 a.m.

Welcome and Introduction of Members and Guests and a Call to Order

The meeting was called to order at 10:05 a.m. by Chairperson, Greg Delaney. Determination of quorum was established for members present and the board was in compliance with notice and agenda requirements of the Oklahoma Open Meeting Act. Members present in person: Sarah Herrian, the Honorable Christine Larson, Daniel Herring, Deanna Chancellor, Dr. Carol Bridges, Christina Siemens, Dr. Kalie Kerth, Lou Truitt-Flanagan, Dr. Greg Parks, Jonette Dunlap, Greg Delaney, Cindy Nocton, and Melanie Johnson. Members present virtually: the Honorable Pat VerSteeg. Members not present: Brandi Watts, the Honorable Louis Duel, Lisa Buck, the Honorable Leah Edwards, David Ross, and the Honorable Bill Baze. OCCY staff members present: Keith Pirtle, Christina Whatley, Kim Rebsamen, Marcia Johnson, Mark James, and Cherra Taylor. Guests present: no guests attended.

- 2. Determination of Quorum and Compliance with Oklahoma Open Meeting Act Quorum was determined and in compliance with the Oklahoma Open Meetings Act.
- 3. Review and Approval of the Meeting Minutes of January 28, 2022, State Post Adjudication Review Advisory Board Meeting

 Discussion and Possible Action

Cindy Nocton motioned, and Lou Truitt-Flanagan seconded approve the minutes of the January 28, 2022, State Post Adjudication Review Advisory Board Meeting. The majority of members present voted in the affirmative, except Dr. Carol Bridges and Deanna Chancellor who abstained. Motion passed.

Jonette Dunlap and Judge Pat VerSteeg arrived at 10:08 a.m.

4. State PARB Previously Identified Issues Updates

Judge Pat VerSteeg provided an update regarding possible elimination of the right to request jury trials. Judge VerSteeg reported that a proposition for legislation was opposed by Senate leadership. Efforts are being made to locate a case or several cases that could be presented to the Supreme Court.

Keith Pirtle, PARB program manager, provided an update regarding priorities of appeals of juvenile cases in the Supreme Court. Keith reported that the delays in resolution were due to late appeal filings at the district court level. The Juvenile Justice Oversight Committee is developing a form and will include the requirement of 30 days from original ruling to file an appeal.

Keith also provided an overview regarding the number of youth aging out of DHS custody without adequate independent living resources.



Sarah Herrian provided an overview regarding children at risk for abuse and neglect due to community isolation. She reported that it was recommended to engage the home school community and get the homeschooling parents involved, increase the identification of abuse, and possibly develop legislative changes in the future.

Handouts of the findings and recommendations were provided.

Christina Siemens arrived at 10:16 a.m.

5. Local Board Recommendations Review

Cindy Nocton presented on the overarching commendations and concerns from the local PARBs. Some of the information reported include:

- Overall approval of staff support of boards.
- Overall approval of training efforts.
- Communication issues with child welfare staff at Oklahoma Department of Human Services (OKDHS), CASA, and attorneys.
- Permanency issues.
- · Issues with recruiting new volunteers.
- · Concerns with turnover at OKDHS and lack of knowledge of PARB among OKDHS staff.
- Lack of knowledge of community resources.
- · Lack of space to hold meetings.

The Board members discussed ways to find possible solutions to the barriers that local PARBs faced. Some of the suggestions were:

- Increase compensation for OKDHS child welfare staff.
- Strengthen transition of cases between child welfare staff.
- Educate judges on domestic violence and its effects on children.
- Local PARBs build relationships with child welfare supervisors and directors.

Handouts of the local board responses were provided.

Judge Pat VerSteeg left the meeting at 10:38 a.m.

6. State PARB Recommendations for 2021 Annual Report

Discussion and Possible Action

Keith Pirtle reported that the 2021 annual report is due to OCCY's Board of Commissioners by May 1, 2022. The last items needed to add to the report are the State PARB Advisory Board's recommendations. Mark James, assistant director of OCCY, stated that the recommendations need to have specific strategies. The Board members discussed the continued support to eliminate the right to request jury trials on termination of parental rights, and to support efforts to reduce the number of youth aging out of custody without a support network and/or other resources. Also discussed was the language that was presented House Bill 3190, which would have implemented sanctions on children's attorneys who inadequately represent their clients.

Sarah Herrian motioned to explore House Bill 3190 and recommend support of the Bill. Dr. Kalie Kerth seconded the motion. Sarah Herrian amended her motion to recommend support of the language of House



<u>Bill 3190. Dr. Kalie Kerth seconded the amended motion. The majority of members present voted in the affirmative except Judge Christine Larson, who abstained. Motion passed.</u>

Chairperson Greg Delaney motioned to recommend continued support of eliminating the right to request a jury trial in the termination of parental rights procedures and recommend continued support to reduce the number of youth who turn 18 while in OKDHS custody with the connections and resources to function in society. Christina Siemens seconded the motion. All members present voted in the affirmative. Motion passed.

7. OCCY Legislative Report

Marcia Johnson, legislative liaison for OCCY, provided an update on the legislative bills regarding children. The bills as they stand are:

- House Bill (HB) 2351 requires the court to assess a child's placement in a residential treatment facility to
 determine if placement is still appropriate after sixty (60) days. The bill is awaiting confirmation of
 schedule to be heard on the Senate floor.
- HB2992 changes the age restrictions of children testifying in an alternative setting outside of the courtroom from under twelve (12) years of age to under eighteen (18) years to coincide with the definition of a child in statute. The bill is awaiting confirmation of schedule to be heard on the Senate floor.
- HB3190 states that the request for a jury trial for a termination of parental rights case must be filed at least thirty (30) days prior to the date of the initial hearing. The bill has died.
- HB3408 adds the "act of deceptive falsification" to the definition of child abuse. The bill has died.
- HB3468 would create the Parent Representation Program with the Administrative Office of the Courts.
 The bill has died.
- Senate Bill (SB) 217 would modify provisions of the Youthful Offender Act. The bill is awaiting confirmation of schedule to be heard on the House floor.
- SB1282 requires the Office of Juvenile Affairs to approve a risk-assessment screening tool to be used when a child is taken into custody. The bill is awaiting the Governor's signiture.

Handouts of the list of bills were provided.

8. Nominations for Chair and Vice-Chair 2022-2024

Discussion and Possible Action

Deanna Chancellor was nominated to be Chair from July 1, 2022 to June 30, 2024. Sarah Herrian was nominated to be Vice Chair from July 1, 2022 to June 20, 2024.

Chairperson Greg Delaney motioned, and Dr. Kalie Kerth seconded to accept Deanna Chancellor as Chair and Sarah Herrian as Vice Chair of the State Post Adjudication Review Advisory Board beginning July 1, 2022. All members present voted in the affirmative. Motion passed.

9. Report from Commission

Dr. Kalie Kerth provided an overview of the Board of Commissioners' activities. She reported on the difficuly of meeting quorum and holding meetings due to many factors. She stated that legislation was primarily discussed at the last scheduled meeting, along with the reappointed of the executive director for another two-year term, and what programs in OCCY are performing well and what programs need improvement.



10. PARB Program Manager's Report

Keith reported that the annual report will be completed by the May 1 deadline. He also reported on the overall annual number of members, cases reviewed, etc. from the previous three years. Highlights of the annual report also include the deployment of the PARB database, and community outreach.

11. New Business

No new business was discussed.

12. Adjournment

The next meeting is scheduled for October 28, 2022.

EXPLANATORY COMMENTS ON THE SCOPE OF THE STUDY PROPOSAL: In this study, we will examine the effects of the government on families within our state. Father's rights and responsibilities will be examined to ensure fathers are receiving the same rights to their children as mothers. The Pinnacle Plan will be reviewed to see if it is helping the children of Oklahoma and examine laws that could be made alongside the Pinnacle Plan to improve the foster care system.

Notes: Children and parents rights need adequate representation. Children should not be bounced around in foster care homes. Parents have a better chance of retaining their rights when a Judge decides.
