DISCUSSION AND POSSIBLE ACTION REGARDING ACCOUNTING OF REAL PROPERTY TRUST

Chief Operating Officer, Durand Crosby, reported that pursuant to our Operating Agreement, the Department is required to give an annual accounting of all of the land that is held in trust. Mr. Crosby stated that the Trustees received an accounting report prior to the meeting, for their review. Shawn McCarty, the Department's Property Manager, was available to explain the transactions for the year.

Mr. Carson asked if there was any cash in this trust in addition to the land and mineral interests. Mr. Bowden stated that the assets that are combining with the Real Property Trust to become the BEST Trust include cash, some stocks and mineral rights. The amount of the cash is around \$900,000 which is currently invested with the State Treasurer in the OK Invest fund.

DISCUSSION AND POSSIBLE ACTION REGARDING QUIT CLAIM DEED CONCERNING LINCOLN COUNTY

Mr. McCarty explained that we have ownership of a property in Woodward County. He asked that the following land be placed into the Trust.

A. The South Half (s/2) of Lots Nine (9), Ten (10), Eleven (11), and Twelve (12), in Block Twenty (20), Vaughn's Addition to the Town of Fort Supply, County of Woodward, State of Oklahoma

Mr. Fisher asked how we received a house in Warr Acres, OK. Mr. McCarty stated that the house was deeded to us from the Department of Rehab Services. It was used as transitional living for individuals who had been at the School for the Deaf. We were unable to use the house for our programming needs. Because the house was in very poor condition making it unusable, and because it was constantly being broken into and vandalized, we had the house torn down. Mr. Fisher asked if we could sell the land and keep the proceeds. Commissioner White stated that by statute we cannot sell the land without running a legislative bill to sell it. However, we can lease the property and keep the proceeds.
