NOTE: Secretary Gatz said this 5 mile segment of the Gilcrease Expressway has been challenging to fund and this arrangement is a great example of local, state and federal government entities working together to leverage their resources to bring a major project forward that would have never happened otherwise. 12. Director's Report

Secretary Gatz said since the last commission meeting, we received some good news out of our Congress. The Congress passed and the President signed their long-term appropriations bill that provides us with federal funding certainty through the end of Federal Fiscal Year 2020. This allows ODOT to continue with our normal operations and continue to deliver our projects for bid and awarding contracts with federal funds through the rest of this federal fiscal year. And it also will provide certainty in some of the Grant Programs that we are often submitting applications for, to try and enhance our ability to deliver some of our major infrastructure improvements. So we'll have those opportunities preserved, and we are really pleased that the Congress was able to do that; and to fund our transportation operations for another year.

We are also working on a Statewide Transit Plan; the new Office of Mobility and Public Transit is a critical part of that. And as part of the Oklahoma Public Transit Policy Plan, the Department and the Oklahoma Transit Association are holding some regional stakeholder meetings in several cities statewide. The meetings are to get local input on the transit needs from both transit providers and users to help shape the State's Transit Program. To get more information about the plan we have started our new transit plan website, which is www.oktransitplan.org.

The Turnpike Authority on this Thursday, January 9th, will cut the ribbon on part of the John Kilpatrick Turnpike extension from I-40 extending south and then back east to Highway 152. That will help, again, as an important reliever route for transportation patterns around the City of Oklahoma City. That airport connection over into that part of Oklahoma City is really, really important; and the type of activities that are going on out in that general area of the City are heavily in the area of distributorships. Hobby Lobby has got a major operation out there and a lot of commercial freight moves in and out of that area. So it's an important project for the Turnpike Authority, and we're really glad to be able to open it up. We won't be able to open all of that facility, so we will do a partial opening, but over the next 2-3 weeks, the rest of it will come open. We are looking forward to getting that one available for transportation.

At this time, I'd like to take just a minute to show you a video of our 2019 Year in review. The staff put this together, and I think it's a really good snapshot of what was going on in 2019. We've got a lot to be proud of!

At this time I would like to talk a little bit about a group that we've got at the Department. We talk a lot about ODOT and the ODOT family; and we have got a committee that's called the, "Committee Who Cares". I want to recognize them because no one exemplifies the ODOT family more than the CWC, it was formed in 1992 to help ODOT employees through staff appreciation events to assist employees who are in need. They have supported employees and their families who were impacted by natural disasters, unexpected financial issues, and medical emergencies, just to name a few. It is made up of employees who volunteer their time and energy to raise money and put on events and programs for ODOT Workers and their families; these folks really go above and beyond to put that together.

I want to first recognize a very special CWC member, Betty Freeman, who spent hours and hours of her free time decorating the beautiful Christmas tree that was in the ODOT lobby this year. She really deserves special recognition, I have been around the Department of Transportation for going on 30 years now, and I have never seen a more beautiful Christmas tree than what we had in our lobby. So Betty, thank you so much for your effort.

This winter, the CWC held a contest at the central office and collected \$4,000 in food and monetary donations and were able to help 20 ODOT families during the holiday season. Their initial goal was to collect enough for 12 families; so our employees exceeded that goal and really came together to help that out. We have got 8 CWC members here today who worked hard to organize the food drive; Corbi Jenkins, Anthony Delce, Arla McCarty, Linda Martin, Daniella Bzdula, Lucy Usiukiewicz and Dana Hogan. Thank you for your efforts, we really appreciate the work that you do for us. And again, they go above and beyond, because they do this in addition to everything else that they do for us and the hard work that they do every day. We had a floor by floor contest and the 2nd floor donated the most at the food drive, and they were the contest winners.

I want to talk a little bit about some upcoming legislative dates that we've got that are significant! We are into the fast approaching legislative season. On January 28th, we have a joint House and Senate Budget Hearing for the Department; so we will be over providing some information to the House and the Senate. And then, next Commission Meeting on February 3rd, Governor Stitt will make his "State of the State Address" at the Capitol, and then we go right into session. So all of that is upcoming, and we are looking forward to a strong 2020 for the Department of Transportation!
