## 93. Additions to the Industrial Access Road Program

## a) Commission District I - Cherokee County

The Cherokee County Commissioners are requesting approval for a lake access project for Fort Gibson Lake. Fort Gibson Lake is located on the Neosho River and lies in Wagoner, Cherokee, and Mayes Counties. Fort Gibson Lake offers six campgrounds and several activities, including fishing, boating, and swimming.

The proposed project begins at the intersection of Sunset Valley Road and Groat Rd, and extends north on Sunset Valley Road for approximately 0.6 miles to W Riviera Road. The project continues west on Riviera Rd for approximately 0.2 miles to N Shoreline Drive. The project then continues north on Shoreline Drive, then curves westerly for approximately 0.4 miles, ending at the boat ramp. The county will be responsible for initiation, construction, and completion of all work associated with the project. The Department's participation cost shall not exceed $\$ 135,000$.

## b) Commission District I - McIntosh County

The McIntosh County Commissioners are requesting approval for a lake access project for Lake Eufaula. Lake Eufaula is located on a 102,000-acre reservoir that offers camping and water activities as well as trails for hiking and biking.

The proposed project begins at the intersection of Texanna Rd and N4220 Rd and extends south approx. 1.14 miles to E1170 Rd. The project continues west on E1170 Rd for 0.4 miles and ends at Bar Harbour Rd. The county will be responsible for initiation, construction, and completion of all work associated with the project. The Department's participation cost shall not exceed $\$ 290,000$.

## c) Commission District I - Wagoner County

The Wagoner County Commissioners are requesting approval for a lake access project for the Verdigris River. The Verdigris River is a tributary of the Arkansas River and is approximately 310 miles long. Boating, fishing and camping are among the amenities offered.

The proposed project begins at the intersection of SH-51B and N4250 Rd and extends 3.2 miles north, ending at the entrance of the Tullahassee Loop Recreational Area. The county will be responsible for initiation, construction, and completion of all work associated with the project. The Department's participation cost shall not exceed $\$ 580,000$.

## d) Commission District II - Leflore County

The Leflore County Commissioners are requesting approval for a lake access project for Kerr Lake. Kerr Lake, also known as Robert S. Kerr reservoir, is the $3^{\text {rd }}$ largest lake in Oklahoma, with 250 miles of shoreline. Camping, boating, and swimming are among the amenities, as well as hiking and nature trails.

The proposed project begins at the intersection of US-59 and Kerr Overstreet and extends southwesterly for approximately1.1 miles, ending at 4630 Rd. The county will be responsible for initiation, construction, and completion of all work associated with the project. The Department's participation in the project shall not exceed \$215,000.

## e) Commission District II - Marshall County

The Pushmataha County Commissioners are requesting approval for a lake access project for Lake Texoma. Lake Texoma is the second largest Oklahoma lake and one of the premier hot spots for striped bass fishing. Lake Texoma also offers camping, swimming, boating, and hiking.

This project begins at the intersection of Texoma Park Rd and Alberta Creek Rd and extends east 2 miles to Washita Point Rd. The county will be responsible for the initiation, construction and completion of all work associated with the project. The Department's participation in the project shall not exceed $\$ 560,000$.

## f) Commission District II - Pittsburg County

The Pittsburg County Commissioners are requesting approval for a lake access project for Lake Eufaula.
The proposed project begins at the intersection of Bucks of Gains Creek Rd and Bugtussle, and extends north on Bugtussle Rd for 2.0 miles, ending at Carl Albert Rd. The county will be responsible for initiation, construction, and completion of all work associated with the project. The Department's participation shall not exceed \$270,000.

## g) Commission District III - Lincoln County

The Lincoln County Commissioners are requesting approval for a lake project for Prague Lake. Prague Lake is a no-wake lake, located six miles northwest of Prague. Visitors to Prague Lake can enjoy fishing or horseback riding on Prague Lake Trail.

The proposed project begins at the intersection of US-62 and Lake Rd and extends north for 2.0 miles, ending at Lloyd Bateson Rd/CR1030. The county will be responsible for initiation, construction, and completion of all work associated with the project. The Department's participation cost shall not exceed \$600,000.

## h) Commission District IV - Payne County

The Payne County Commissioners are requesting approval for a lake project for Lake Carl Blackwell. Lake Carl Blackwell is a 3,350-acre lake operated by Oklahoma State University. Fishing, swimming, boating, hiking and mountain biking are among the amenities offered.

The project begins at the intersection of SH-51 and Redlands Rd and extends north 2.0 miles to Lakeview Rd, then extends west 1.0 miles, ending at the lake. The county will be responsible for initiation, construction, and completion of all work associated with the project. The Department's participation shall not exceed \$850,000.

## i) Commission District V - Custer County

The Custer County Commissioners are requesting approval for a lake access project for Foss Reservoir. Foss Reservoir, also known as Foss Lake, is located fifteen miles west of Clinton. Its amenities include fishing, boating, camping, and hiking.

The proposed project begins at the intersection of SH-33 and N 2130 Rd and extends south for 4.0 miles to 990 Rd. The project then extends west on 990 Rd for 1.5 miles, ending at Culberth Trail. The county will be responsible for initiation, construction, and completion of all work associated with the project. The Department's participation shall not exceed \$125,000.

## j) Commission District V - Kiowa County

The Kiowa County Commissioners are requesting approval for a lake access project for Tom Steed Reservoir, which lies northeast of Altus. Swimming, camping and hiking are among the amenities.

The proposed Project begins the intersection of US-183 and E1570 Rd and extends west on E1570 road for 0.8 miles, ending at the railroad track. The county will be responsible for initiation, construction, and completion of all work associated with the project. The Department's participation shall not exceed \$110,000.

## k) Commission District VI - Ellis County

The Ellis County Commissioners are requesting approval for a lake access project for Lake Lloyd Vincent. Lake Lloyd Vincent is located thirteen miles southwest of Arnette and its amenities include boating and fishing.

The proposed Project begins at the intersection of CR173 and CR64 and extends south 4.0 miles to CR67. The county will be responsible for initiation, construction, and completion of all work associated with the project. The Department's participation shall not exceed $\$ 300,000$.

## I) Commission District VII - Carter County

The Carter County Commissioners are requesting approval for a lake access project for Lake Murray. Lake Murray is home to Lake Murray State Park, which is Oklahoma's largest state park. Amenities include camping, boating, fishing, swimming, as well as ATV rental at the nearby ATV campground.

This project begins at the intersection of US-70 and Dogwood Rd and extends south, then curves east for approximately 0.8 miles. The county will be responsible for initiation, construction, and completion of all work associated with the project. The Department's participation shall not exceed \$185,000.

## m) Commission District VIII - Delaware County

The Delaware County Commissioners are requesting approval for a lake access project for Lake Eucha. Lake Eucha offers forty-nine miles of shoreline and 2,860 surface acres of water. Amenities include boating, swimming and camping.

This project begins where existing pavement ends on CR595/587 and extends northwesterly, then southwesterly, then east for approximately 1.3 miles, ending at the intersection of CR587 and CR495. The county will be responsible for initiation, construction, and completion of all work associated with the project. The Department's participation shall not exceed \$265, 000.

## n) Commission District VIII - Pawnee County

The Pawnee County Commissioners are requesting approval for a lake access project for Keystone Lake. Keystone Lake is a Corps of Engineers-operated Lake located on the Arkansas River. Keystone Lake offers 330 miles of shoreline and sixteen recreational areas for boating, fishing, and mountain biking.

The proposed project begins at the intersection of US-64 and Dixie Road and extends east for approximately 0.9 miles, then extends north for approximately 0.6 miles, ending at E0530 Rd. The county will be responsible for initiation, construction, and completion of all work associated with the project. The Department's participation shall not exceed $\$ 275,000$.

## ITEM PRESENTED BY THE DIRECTOR - Mr. Gatz

## 96. Director's Report

Secretary Gatz began his report by thanking the legislature and Governor Stitt for naming the I-35 and State Highway 51 interchange the "Designation of the Honorable Secretary Gary M. Ridley Memorial Interchange". Secretary Ridley, early in his career managed traffic through that interchange location. Ridley also recognized the challenge that a substandard interstate design and an interchange design brought to managing that traffic. Ridley always worked to improve that interchange and make it safer for the traveling public and as always, that
was in the front of his mind. Secretary Gatz thanked Eula and Daphne Ridley and Caleb for joining ODOT in designating the interchange in Ridley's honor.

Secretary Gatz stated that he also appreciated the Commission's consideration of ODOT's budget work program an important milestone that is brought in front of Commission every June. Gatz mention The Rural Economic Transportation Reliability and Optimization Fund, the one-time appropriation of $\$ 200$ million that will help the State of Oklahoma address developing issues that the rural areas.

Secretary Gatz moves on to says was a great honor to join Lieutenant Governor, Matt Pinnell and Tulsa Mayor, GT Bynum on Route 66 to unveil a Route 66 Bike Route sign. He states this route signage and the designation along the rest of Route 66 is first and foremost, a safety concern. The designations alerts the traveling public in vehicles that there could be bicycles present along that route. He mentions that anyone traveling that route should be mindful of that safety concern and plan their route carefully and make sure their skill levels match some of the challenges that they might encounter and experience. The Commissioners were thanked for their support of that route designation and there will be more of this activity prior to the Centennial celebration in 2026.

The Heartland Flyer was recognized by Secretary Gatz and was named as a top ground travel provider in the Southwest by Wanderu Passengers Choice Awards. They allow travelers to compare and book bus and train travel across North America and Europe. And the award was voted on by passengers. This highlights the fact that the Heartland Flyer offers a very high level of convenience and a super alternative transportation mode.

Secretary Gatz recognizes ODOT's major, upcoming project starting with the I-35 and I-240 interchange improvement. The duration of the project is two years and features a new turnaround at Southeast 59th, rehabilitation of east and westbound I-240, Frontage Roads and Poe Road, a replacement of a railroad bridge over I-240 and construction of a new northbound I-35 to eastbound I-240 off ramp. This is a multi-phase, cloverleaf interchange design and ODOT is seeking to improve that interchange's functionality and safety as both I-35 and I-240 moves a significant volume of traffic. Gatz mentions that in the course of construction, traffic will be disruptive and ODOT is looking forward to the completion of this project.

In an additional project update, Secretary Gatz brings attention to $\mathrm{l}-35$ at Northeast $63^{\text {rd }}$ Street. ODOT had a successful full closure of northbound last week which allowed the Contractor to hang bridge beams for the new northbound I-35 to westbound I-40 for the flyover ramp. Gatz thanked the public's patience with traffic disruptions as ODOT works to complete major improvements at these locations in the safest way that was possible. He adds that there will likely be a few more light closures in the interchange as the project continues through 2025.

Secretary Gatz adds an update to the I-40 and Douglas Boulevard, including the projects occurring in that area. Gatz adds that last month, ODOT did a full closure of l-40 at Midwest City to remove the Ingle Road bridge. There were approximately 60 personnel present and working on the project. Crews were able to cut the bridge free and get it off the interstate in just more that 48 hours. Gatz stated the removal allowed ODOT to widen l-40 to six lanes and make this improvement as safe as possible. He adds that the l-40 and Douglas Boulevard interchange is going to be a new single-point urban interchange, the fourth of its kind in the metro area. This is a $\$ 170$ million project that started in April 2023 and will take approximately two years to complete. He congratulated District Four, Trenton January and Allen Construction, the Contractor.

Secretary Gatz recognized "Secure Your Load" as ODOT's safety campaign for the month of June. Gatz stated that Secure Your Load is a national campaign to remind and encourage drivers to make sure whatever they are hauling is secure in their vehicle. ODOT and Turnpike Authority are joining Keep Oklahoma Beautiful, the Oklahoma Highway Safety Office and the Department of Public Safety to recognize National Secure Your Load Day as Tuesday, June the $6^{\text {th }}$. Gatz adds that Governor Stitt as declared June $6^{\text {th }}$ through June $12^{\text {th }}$ as Secure

Your Load Week in Oklahoma. ODOT requests that whether you are hauling something in the bed of your pickup, make sure it is tied down, and equipment, make sure it is chained down, including the boom if it has one. Gatz points out the couple of bridge hit times on the June agenda from overheight vehicles striking a bridge. If you believe you are close to the 14 -foot legal height limit, it is best to double check the measurement on it. The campaign is designed to make roads safer and help reduce litter in the state and certainly to be mindful of everything that goes on and off ODOT's highways every day. ODOT and OTA maintenance forces spend more than $\$ 6$ million a year to pick up debris and litter annually along the highways which is in addition to the many efforts by volunteers. Also, nationally in 2019, there were 739 deaths and nearly 90,000 crashes cause by road debris. Drivers can decrease their chances of being involved in road debris crashes by securing vehicle loads, maintaining their vehicle and driving defensively. Gatz addressed the public that the first line of defense is your seatbelt and to buckle up.

Commissioner Grimsley stated his concern of the Contractors facing a lot of volatility and pricing issues. Grimsley adds that some of the asphalt contracts are having trouble and are paying liquidated damages for the first time in their history. He adds that it would be in everyone's best interest if ODOT could continue to be vigilant and invest more time in how the pricing is estimated or tracked. Grimsley stated that it has a bit more of a significant impact on the rural communities because those same contractors supply our cities and our counties and are also a part of our economy.
Gatz commended on ODOT's team for an exceptional job of meeting with the contractors and working out these issues as they arise, being mindful of both protecting the taxpayer dollars and making sure that ODOT is not posing a hardship on the Contractors.
