# RE: Toviaz®, Cerdelga®, Zavesca®, Alphagan® P, Zioptan®, Ciprodex®, and Floxin® Otic Coverage Changes Effective March 25, 2024

The following changes will take effect March 25, 2024. Complete prior authorization (PA) criteria can be found on the OHCA website at <a href="https://oklahoma.gov/ohca/pa">www.oklahoma.gov/ohca/pa</a>. Pharmacy PA forms can be found on the OHCA website at <a href="https://oklahoma.gov/ohca/rxforms">https://oklahoma.gov/ohca/rxforms</a>.

#### Toviaz®

Toviaz® (fesoterodine) will be brand preferred. Members currently utilizing generic fesoterodine will need to switch to brand Toviaz®. The specific PA requirements and tier chart for the Bladder Control Medications can be found on the OHCA website in the "Genitourinary System" therapeutic category.

# Cerdelga® and Zavesca®

Cerdelga® (eliglustat) will require prior authorization. Members currently utilizing Cerdelga® will be approved for continuation of therapy.

Zavesca® (miglustat) will be brand preferred. Members currently utilizing generic miglustat will need to switch to brand Zavesca®.

The specific PA requirements for the Lysosomal Storage Disease Medications can be found on the OHCA website in the "Genetic Disorders" therapeutic category.

## Alphagan® P and Zioptan®

Alphagan® P (brimonidine) and Zioptan® (tafluprost) will be brand preferred. Members currently utilizing generic brimonidine or tafluprost will need to switch to brand Alphagan® P or Zioptan® respectfully. The specific PA requirements and tier charts for the Glaucoma Medications can be found on the OHCA website in the "Ocular/Otic" therapeutic category.

# Ciprodex® and Floxin® Otic

Ciprodex® (ciprofloxacin/dexamethasone) will be moved to tier-2 of the otic anti-infectives tier chart. Floxin® Otic (ofloxacin) will be moved to tier-1 of the otic anti-infectives tier chart. The complete tier chart can be found on the OHCA website in the "Ocular/Otic" therapeutic category.
