RE: Flu Vaccine Coverage for the 2023-2024 Flu Season

Flu Vaccine Coverage

- Flu vaccines are available to members 19 years of age and older through both the SoonerCare prescription drug benefit and the medical benefit.
- Flu vaccines administered by pharmacies do not count against a member's monthly prescription limit, and there is no copay to members.
- Members 18 years of age and younger must receive the flu vaccine through a federal Vaccines for Children (VFC) Program provider.
- Vaccine Billing Guidance is outlined in Table 1 below.
- Only the outer package NDCs listed below are covered.

Vaccine Billing Reminders

- **Nursing Home:** As a reminder, influenza and pneumococcal vaccines are not separately payable for SoonerCare members residing in a nursing home. The nursing home is responsible for providing these as part of their payment from SoonerCare.
- **Pharmacy:** ACIP-recommended vaccines have an administration fee of \$18.34 and should be billed to SoonerCare with the SCC code "42" only. COVID-19 vaccines are eligible for an enhanced administration fee when billed appropriately. During OHCA claim audits, if ACIP-recommended vaccines were billed using SCC codes for COVID-19 vaccines resulting in an administration fee other than \$18.34, then OHCA will recoup the difference in the administration fee. Billing and administration fee information for all vaccines is as follows:
