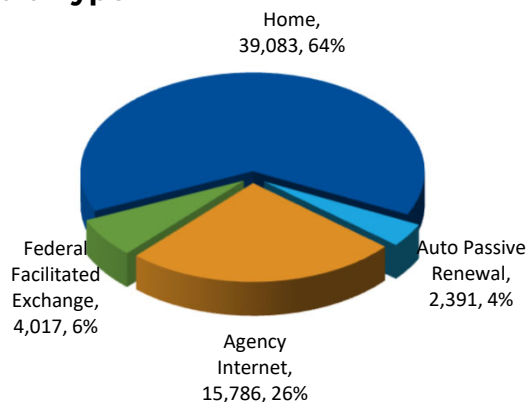

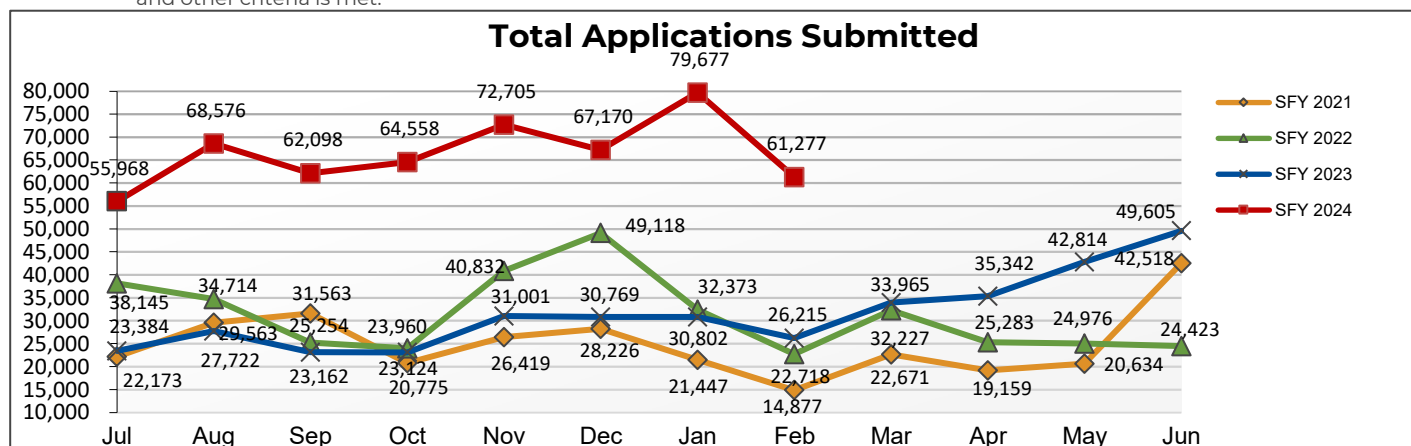

Media Type



The **Media Type** tracks how the information (application) was submitted. Some rural areas may not have Internet access, therefore might continue submitting their information on paper applications. Agency Electronic consist of partner agencies submitting applications on behalf of the patient and/or recipient/member.



Effective SFY2017 passive renewals (members automatically enrolled having met the necessary criteria) and the federal exchange populations are included. Increase starting in 2023 due to restarting renewal process

Applications are based on household, not each individual member. Therefore, the Member Total will be higher than the Application Total.
