

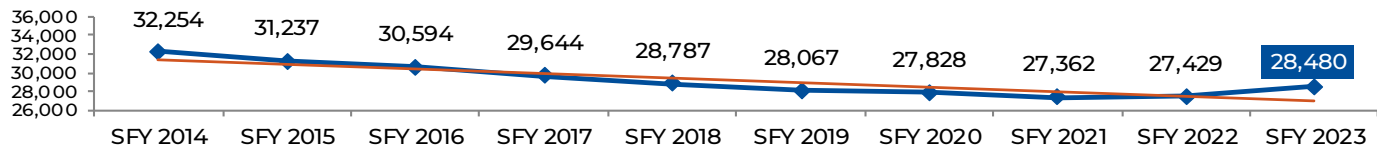
SoonerCare Delivery Fast Facts

State Fiscal Year 2023



Below are SoonerCare mothers with delivery date July 1, 2022 through June 30, 2023. Data is based on mother's paid claims with delivery codes; it may include non-live births. Mothers with multiple delivery dates will be counted multiple times; mothers with multiple infants on the same delivery date will be counted once. Data may include members with third party liability or Medicare.

SoonerCare Deliveries (Mother Count)

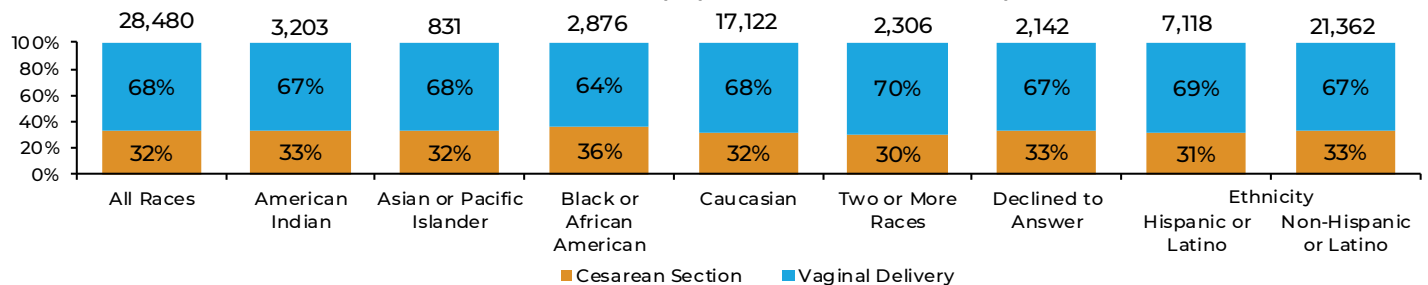

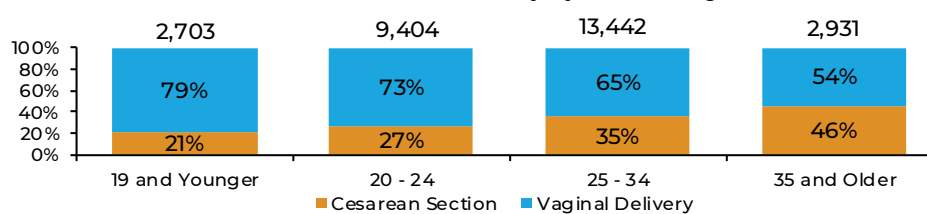
Race is self-reported by members at the time of enrollment. Members who selected two or more races are grouped with two or more races category. Hispanic or Latino is an ethnicity, not a race and is reported separately. Data is based on mother's age at the time of delivery.

Method of Delivery by Mother Race and Ethnicity

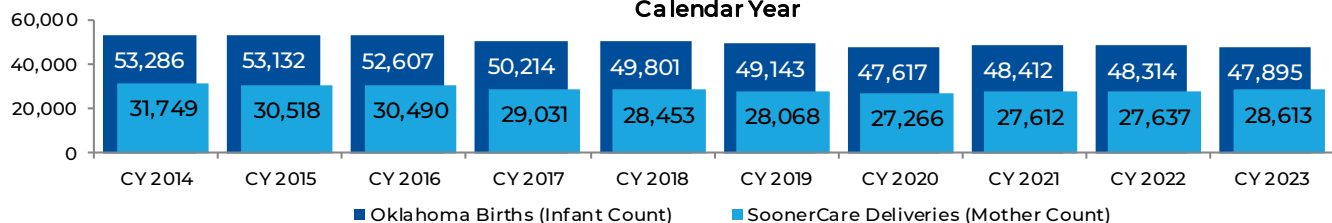


Method of delivery is based on inpatient claims and professional claims; provided by physician, nurse midwife, nurse practitioner, and physician assistant.

Oklahoma Births and SoonerCare Deliveries Calendar Year

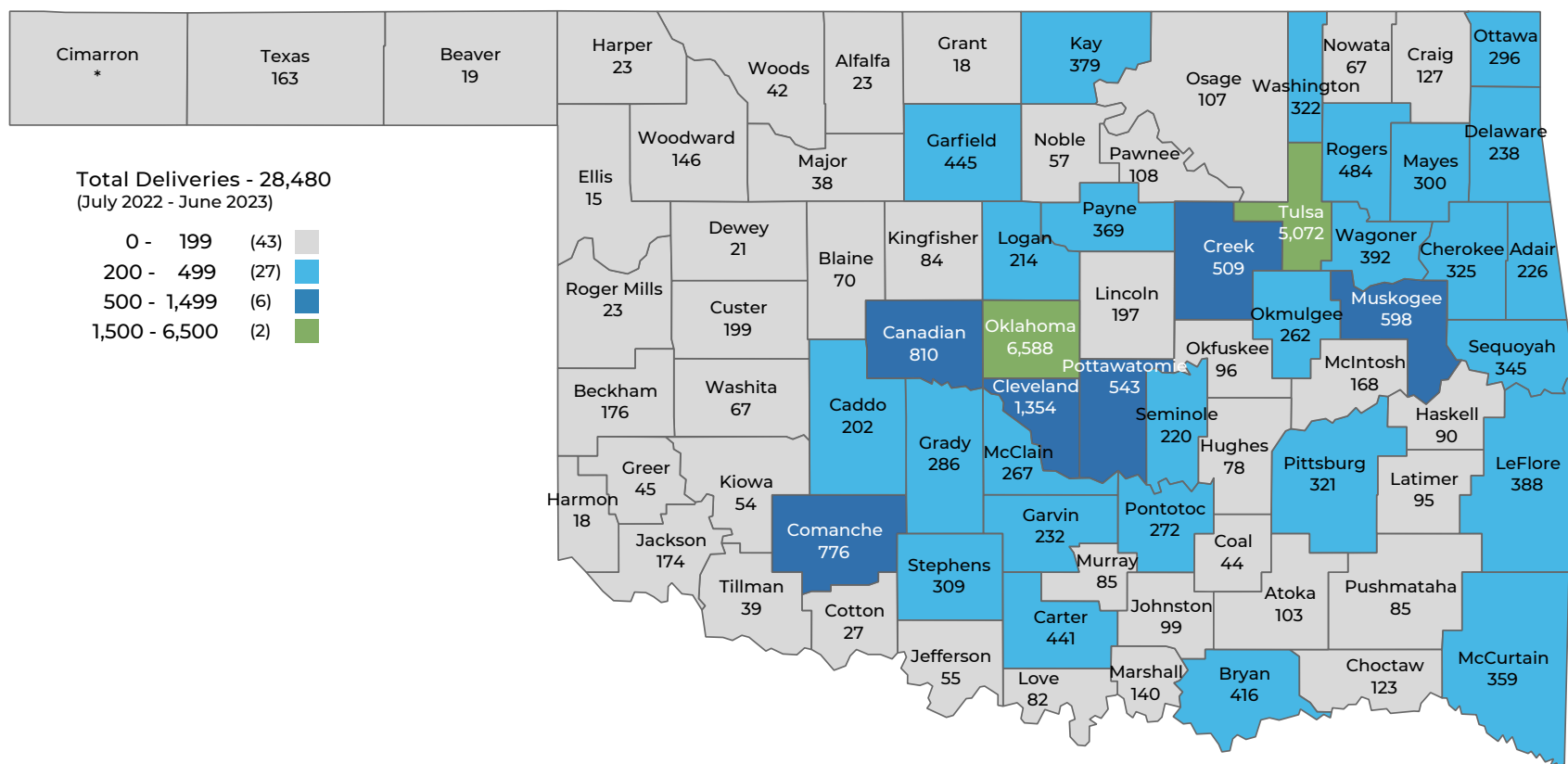


Oklahoma Births numbers are from Oklahoma State Department of Health, it refers to live birth infants. SoonerCare Deliveries numbers are from OHCA, it refers to mothers that had a delivery; it may include non-live births. Both data sets are limited to Oklahoma residents regardless where the delivery occurred; it may include births/deliveries that took place in an out-of-state facility.
