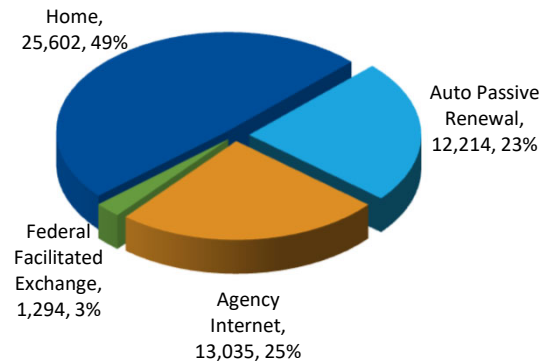

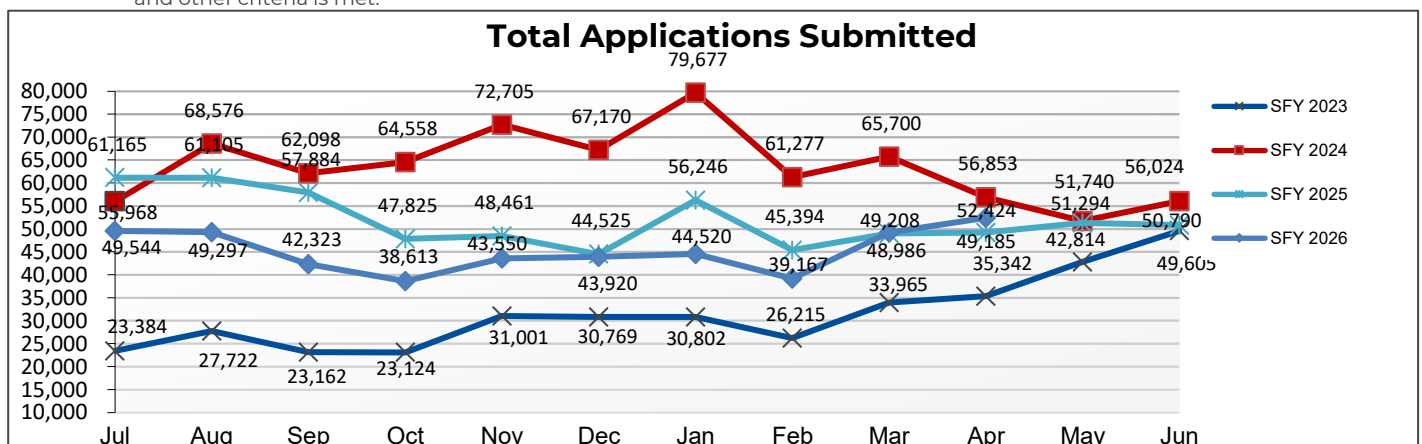

- Members are passively renewed when their income and other criteria is met.
