Budget update

The OHCA Board was presented with the agency's State Fiscal Year (SFY) 2016 budget request at their October 9 meeting. In addition to the agency's base funding of approximately \$953 million in state funds, OHCA is requesting an additional \$163.6 million needed to maintain the existing program. This includes replacement of lost federal dollars, four percent program growth, a federal mandate for an in-house administrative law judge and replacement of one-time carryover funds—representing the top four budget priorities for the agency.



The Federal Medical Assistance Percentage (FMAP) used to determine the amount of federal

matching funds for state Medicaid expenditures will continue its downward trend for Oklahoma by decreasing in SFY2016. The rate will decrease from 62.30 percent to 61.25 percent and create a need for \$39 million in additional state funds. This follows a reduction of 1.72 percentage points in SFY 2015. FMAP is the federal funding formula based on a state's per capita income relative to that of other states using a three-year rolling average.

The request also includes \$14.1 million additional state dollars to cover children who qualify for SoonerCare through the Children's Health Insurance Program (CHIP). CHIP provides an increased match rate of 72.88 percent for services provided to children from 133 percent to 185 percent of the Federal Poverty Level, and is currently before Congress for possible reauthorization. If the program is not reauthorized, these children will remain in the SoonerCare program, but will receive the regular match of 61.25 percent. However, if CHIP is reauthorized through Federal Fiscal Year 2019, the match rate will increase to 96 percent and the OHCA's request for additional state funds will decrease by \$42 million.

A projected growth rate of four percent in the SoonerCare (Oklahoma Medicaid) program would require an additional \$45 million. One-time carryover funding of \$61 million makes up a large part of the agency's current SFY15 budget, and must be replaced in SFY16.

In addition to maintenance of the existing program, OHCA is asking for almost \$102 million to restore

provider rates to pre-SFY 2010 levels. The agency cut rates for most provider groups by 3.25 percent in SFY 2010 and an additional 7.75 percent on July 1.

The agency is also asking for an additional \$7.6 million to increase Disproportionate Share Hospital (DSH) funding to the maximum allowable level. Federal law requires state Medicaid programs make DSH payments to qualifying hospitals that serve a large number of Medicaid and uninsured individuals.

The remaining budget request items total approximately \$1.5 million and include advanced genetic testing for developmental delays, contract expenditures, software and removal of monthly limits for certain medications. The request includes a total of 11 priorities totaling an additional \$275 million in state funds.

SoonerCare providers: Does your contract include Insure Oklahoma?



Thousands of low-income adult Oklahomans have enrolled in Insure Oklahoma (IO) to help meet their health insurance needs.

If your practice includes adults ages 19-64, but your SoonerCare contract does not include IO, consider enrolling as a provider through a simple contract addendum. IO billing practices are the same as

SoonerCare (except dental claims), so providing services through IO will be familiar. Call Provider Services at 800-522-0114, option 5, for more information.

IO members pay low health insurance premiums and copays for covered services. To enroll in an individual plan, members must earn at or below 100 percent of FPL and meet additional qualifications.

Short-acting opioid quantity limits

Effective Nov. 1, 2014, SoonerCare will be applying a quantity limit for reimbursement on short-acting, oral opioid pain medications. The quantity limit will be phased-in over a 3-month period. The maximum quantity for which SoonerCare will reimburse is 120 units for a 30-day supply. Below is a list of dates and medications that will be affected by the new quantity limit edit.

Synagis® new prior authorization process

The SoonerCare prior authorization (PA) process for Synagis® has added the option for the neonatologist or other specialist to begin the PA process prior to discharge from the hospital or upon referral. The specialist can decide to follow the patient throughout the respiratory syncytial virus infection (RSV) season or defer care to the infant's primary care provider (PCP).

The following new process will involve both providers:

1. Find form PHARM-7 on the SoonerCare website.

2. Specialist prescriber completes the necessary information on the PA request form and signs it.
· Patient information and criteria for Synagis® coverage
· Specialist prescriber information
PCP prescriber information (name, address, phone and fax numbers)
3. Specialist prescriber forwards the PA form to Synagis® provider (pharmacy or clinic).
4. Synagis® provider completes the form with provider and product information (NDC for pharmacies and CPT for clinics/outpatient).
5. Synagis® provider faxes the PA request to the Pharmacy Authorization Unit (PAU).
6. The PAU will fax the decision response to all three providers (specialist prescriber, PCP prescriber, and Synagis® provider) within 24 hours of receipt.

Dental
Claim form changes

Effective Oct. 17, 2014, OHCA will accept the American Dental Association 2012 claim form. This

change affects all contracted dental providers.

OHCA will accept both the ADA 2006 and ADA 2012 claim forms until Dec. 17, 2014. After Jan. 1, 2015, only the ADA 2012 claim form will be accepted.

Oklahoma meets first-year Oral Health Initiative goal

In 2010, the Centers for Medicare & Medicaid Services (CMS) announced the Oral Health Initiative (OHI) to promote and improve the delivery of dental and oral health services in Medicaid and the Children's Health Insurance Program (CHIP). Under the initiative, state Medicaid and CHIP programs are encouraged to



increase the number of children (ages 1-20) receiving preventive dental services such as dental sealants, prophylaxes and topical fluoride treatments by federal fiscal year (FFY) 2015. CMS is working with the states to increase service utilization for these pediatric dental patients by 10 percentage points over an established baseline. For Oklahoma, that baseline is 44 percent.

CMS recently reported that between FFY 2011 (the baseline year) and FFY 2012, Oklahoma was one of 15 states to achieve at least a two percentage point (to 46 percent) improvement on their CMS Oral Health Initiative goal, the interim yearly improvement goal. The FFY 2015 goal for Oklahoma is 54 percent.

Oklahoma Text4Baby project is on the button



There are lots of exciting things happening with <u>Text4Baby</u> (T4B), a free mobile health message service for expectant and new mothers. The project, in which OHCA is a major partner, has been featured recently on both KOCO-TV news and Oklahoma News Report (ONR) on OETA-TV,



Oklahoma's statewide PBS network.

In recent months, T4B has developed partner outreach materials specific to the four states involved in the initiative's pilot project, which includes Oklahoma. In addition to the normal tearpads, promo flyers and referral cards, Oklahoma T4B partners can now order bilingual flyers that have a comprehensive program description and are great for mailings or kits for pregnant women and new moms. Most recently, a project at OHCA has been able to automatically send T4B opt-in messages to pregnant women upon their enrollment in SoonerCare. The initial push was a great success, breaking the T4B single-day enrollment record. OHCA is the first state Medicaid agency to implement this enrollment process.

Providers and their staff are crucial in getting their patients enrolled in T4B and helping them to better prepare for motherhood. Policy

Policy changes requested for DHS waivers

Providers serving members with intellectual disabilities in home and community-based services waivers may be interested in rule revisions being proposed by Developmental Disabilities Services at the Oklahoma Department of Human Services (DHS).

Amendments related to the application process and administration of the statewide Request for Waiver Services list are proposed along with changes to the agency companion rules. In the application process rules, new timeliness standards based on applicant age are established, address change notification is addressed and provision is made for requesting reinstatement to the waiting list if removed.

An additional proposed rule change establishes that the Agency Companion Service is provided by an independent contractor of a provider agency and makes other corresponding revisions to the policy. The rule is proposed to ensure compliance with new federal labor regulations.

As the single state Medicaid agency, OHCA is responsible for promulgating all policy related to the SoonerCare program. From time to time, other agencies, such as DHS, may recommend changes in policy pertaining to their areas of responsibility.

DHS is responsible for the operation of four waivers serving individuals with intellectual disabilities. These are Community, Homeward Bound, In-home Supports for Children and In-home Supports for Adults.

The rule changes are open for public comment until November 20 and will be considered by the OHCA Medical Advisory Committee (MAC) that afternoon. The OHCA Board will take action on the proposed rules at the December 11 meeting.

Postponed: diabetic supply billing process changes

The transfer of diabetic supply billing processing to the Pharmacy point-of-sale method has been postponed. This change was originally due to occur on Oct. 1, 2014.

OHCA will issue a 60-day notice prior to implementing the change.

We have also recently added a <u>tutorial on accessing and utilizing the OHCA Provider Portal</u>, from the 2014 Fall Training Workshops. The PowerPoint gives detailed information on checking the prior authorization (PA) requirements for a code, submitting online PA requests, how to access our remarks (to see if there are issues with your PA request), and more.

While on the OHCA Board, Sen. Miller served as chairman of the Committee on Audit and Finance, offering valuable insight, leadership and guidance to the agency. Sen. Miller is well-reputed for always working to ensure that qualified Oklahomans received the health care they needed.

At the October OHCA board meeting, Sen. Miller was presented the 2014 Dr. T.J. Brickner Defender of Health Award by board Chairman Ed McFall. The award, named after a founding OHCA board member, serves to recognize individuals committed to serving the low income, uninsured and underinsured residents of Oklahoma.
