

## **FINANCIAL REPORT**

For the Ten Months Ended April 30, 2009 Submitted to the CEO & Board June 25, 2009

- Revenues for OHCA through April, accounting for receivables, were \$2,598,743,966 or 1.2% over budget.
- Expenditures for OHCA, accounting for encumbrances, were \$2,602,075,602 at (1.4%) variance with the budget.
- The state dollar budget variance through April is \$6,499,633 negative.
- In addition to the SFY09 variance, the agency has **\$6,717,455** in uncommitted prior year carryover.
- The budget variance is primarily attributable to the following (in millions):
