# Oklahoma's Federally-Facilitated Marketplace (FFM)


- All states will have an Insurance Exchange or Insurance Marketplace where consumers can directly compare, purchase, and enroll in Qualified Health Plans (QHPs) through an online portal
- The United States Department of Health and Human Services (HHS) through the Center for Consumer Information and Insurance Oversight (CCIIO) will implement and operate a Federally-Facilitated Marketplace (FFM) in Oklahoma
- Consumers (with incomes between 100-400% of the Federal Poverty Level) can apply for Advanced Premium Tax Credits (APTCs)
