SUMMARY

OCAS: Not operating pursuant to OCAS

- 1) Issues with purchasing procedures including purchase order.
- 2) Board not approving encumbrance reports in a timely manner (after purchases).
- 3) Comingling general funds (Fund 11) and school activity funds (Fund 60).
- 4) Credit cards issues including failure to maintain proper documentation.
- 5) Non-allowable purchases from the General Fund include catering, gift cards, and personal gifts.

SPR: Incorrect data was certified as correct. Report was reopened to correct errors in FY23 and FY24. Job titles did not align with OCAS coding requirements-directors were improperly coded. Administrative job codes were changed from FY22 SDE-review. KIPP OKC shared employees incorrectly & entered as 1.0 Full Time Employees (FTE) at each charter school. KIPP's board did not approve employment contracts as legally required.

Paraprofessional Certification: Employee never applied to be approved as a 414 Tier 1 Para resulting in noncompliance.

Dropout Report: Dropout report/college remediation report were not presented to the board.

Open Meeting Violations:

- 1) Not using the proper legal citation for executive session (11/28/24) & taking action without citing in agenda item.
- 2) Minutes do not meet statutory requirements-lacking required details, use of only first names, containing mistakes and omitting outcomes.
- 3) Vague agenda items for every meeting that did not state possible actions and are not easily understood by the public.

Additional Note of needed improvement with no deficiency issued: Library book list must be uploaded to the SSO Accreditation Upload app. Kipp Tulsa **MUST** be better prepared for SDE visits.
