Approved Assessment for 9th, 10th, and 12th Grade ELP Band Exit

ACT Suite of Assessments:

- Qualifying score is a **Reading subtest** score at or above the national 35th percentile.
- Please create an ELP Band Exit DVR in Accountability Reporting and attach the individual score report indicating the national percentile in **Reading**.

SAT Suite of Assessments:

- Qualifying score is an **Evidence-Based Reading and Writing Score** at or above the national 35th percentile (score is the composite derived from the *Reading and Writing and Language* section subscores).
- Please create an ELP Band Exit DVR in Accountability Reporting and attach the individual score report indicating the national percentile in **Evidence-Based Reading and Writing**.
