

NORM-REFERENCED TESTS APPROVED FOR “LESS OFTEN” NON-EL BILINGUAL QUALIFICATION



The assessments detailed below are approved for use when qualifying a “less often” student for Non-EL Bilingual status. Note that regardless of the “more often” or “less often” status of the student (determined by the current Home Language Survey responses), a student assigned Non-EL Bilingual status must first demonstrate English language proficiency, either through the initial administration of the PKST or appropriate WIDA Screener or through subsequent participation in the WIDA ACCESS or Alternate ACCESS assessments.

For the purposes of “less often” Non-EL Bilingual qualification, the range of allowable assessments, variations in scoring and reporting methods, and the norm-referenced nature of the assessments themselves limits the ability to determine of a qualifying score for each assessment across all of its applicable grade levels. As such, some interpretation may be necessary to determine if a score qualifies a “less often” student for Non-EL Bilingual status. Generally, a qualifying score must be at or below the 35th percentile, but in cases where the assessment does not report scores in percentile format, this rule may be interpreted as a score in the bottom third of the assessment’s scoring range. Regardless of the assessment and its associated reporting, the ability to determine a student’s level of achievement relative to those upon which the assessment was normed should be available to the LEA. Please note that this information may be requested by the LEA’s assigned Regional Accreditation Officer for the purposes of the annual Bilingual Audit.

Lastly, the use of any assessment below for the purposes of “less often” Non-EL Bilingual qualification in the current year is not allowable if the student achieved a score of Proficient or Advanced on their previous year OSTP ELA assessment or a score deemed to be proficient on their prior year CCRA/ACT US Rank Reading Percentile.
