U.S. Silica is in receipt of OWRB letter, subject as above, dated December 15, 2022. U.S. Silica's check in the amount of \$500.00 to cover the administrative review fee was submitted under separate cover.

Attached please find a revised 2021 annual report, the 2022 fourth quarter report, and the 2022 annual report.

OWRB Rules 785:30-15-4(a)(2) Mines with preexisting exemptions requires that mines submit quarterly and annual reports that provide the following information:

- Measured or reasonably estimated volumes water entering the pit including the following:
  - Groundwater
  - Surface Water
    - Stated separately.
- Total volume of water diverted from the pit.
- Disposition of the water from the pit.
- Consumptive use of the water from the pit.

Per the received letter from OWRB Staff as well as an additional review of US Silica's quarterly and annual report, the report was revised. This revised report contains all the information as required in OWRB Rules 785:30-15-4(a)(2). The information provided in the revised report can be used to clearly calculate the total MEPS used quarterly and annually.

In addition, the revised report also contains the following items in addition to those required in OWRB Rules 785:30-15-4(a)(2):

- U.S. Silica's permitted groundwater value of 70.4 acre-feet per year.
- U.S Silica's EPS of 777 acre-feet
  - Separated by owned and leased volumes.
