OKLAHOMA TAX COMMISSION REGULAR MEETING MINUTES June 3, 2025

1. The regularly scheduled meeting of the Oklahoma Tax Commission convened at 1:30 p.m. on the above date. Notice of said meeting was posted on December 10, 2024; and the agenda therefor was posted from and after 1:30 p.m. on June 2, 2025. Chairman Wood declared the presence of a quorum.
