## OKLAHOMA TAX COMMISSION REGULAR MEETING MINUTES September 3, 2025

1. The regularly scheduled meeting of the Oklahoma Tax Commission convened at 1:30 p.m. on the above date. Notice of said meeting was posted on December 10, 2024; and the agenda therefor was posted from and after 1:30 p.m. on September 2, 2025. Chairman Wood declared the presence of a quorum.

- 2. READING OF MINUTES Vice-Chairman Paulk moved that the Commission approve the minutes of the regular commission meeting on August 26, 2025. Secretary-Member Taylor seconded the motion. Chairman, aye; Vice-Chairman, aye; Secretary-Member, aye. The motion was declared adopted.
