To the People of Oklahoma:

The Office of the State Treasurer is pleased to issue the August monthly investment performance report. I trust you will find it thorough and in keeping with my commitment to provide disclosure of the economic environment and portfolio results. As always, my staff and I are available to answer any questions.

Market Conditions

On August 5, the 10-year treasury benchmark yield cratered and dropped 0.32% below the 3-month bill reflecting the "most extreme yield-curve inversion since just before the 2008 crisis" as reported by Bloomberg News. It is expected that treasury yields will continue to invert as investors seek refuge in less risky markets. Treasury yields as of August 31 were 1.983% for the 3-month, 1.765% for the 1-year and 1.498% for the 10-year. The 30-year was at 1.964%.

The major stock indexes struggled during August with the S&P 500, the Dow Jones and Nasdaq falling 1.8%, 1.7% and 2.6%, respectively. The S&P finished the month at 2,926, the Dow was at 26,403 and Nasdaq at 7,962.

The minutes from the July Federal Open Market Committee indicated the 0.25% interest rate cut was a proactive approach in regard to concerns about the continuing trade war with China. According to the Wall Street Journal, "The minutes revealed a greater split over the inflation outlook. While some officials believed weaker growth abroad and trade tensions between the U.S. and other countries would push the Fed farther away from reaching its 2% target, many others weren't as concerned". In addition, the minutes also mentioned that "Most participants viewed a proposed quarter-point policy easing at this meeting as part of a recalibration of the stance of policy, or mid-cycle adjustment, in response to the evolution of the economic outlook over recent months".

Economic Developments

The nonfarm payrolls for July came in at 164,000, missing expectations by only 1,000 jobs. Nonfarm payrolls for previous months were downwardly revised, with June dropping from 224,000 to 193,000 and May being reduced from 72,000 to 62,000. Bloomberg News reported that "The job gains were led by service providers, particularly in education and health services, as well as professional and business services. Retail payrolls fell for a six month, while manufacturing added the most in six months. Construction gains were relatively weak, at 4,000". The unemployment rate was at 3.7% reflecting no change from the month before.

The headline consumer price index (CPI) for all items was up 0.3% in July and on an annual basis came in at 1.8%. Shelter and gasoline costs rose by 0.3% and 2.5%, respectively. Core CPI, which excludes food and energy costs, was at 0.3% for the month and 2.2% year-over-year. According to Bloomberg News, "The index rose an annualized 2.8% of the past three months, the most since early 2018. The two-month gain of 0.6% was the most in more than a decade". The headline and core monthly CPI surpassed economists median estimates. The headline and core producer price index (PPI) came in at 0.2% and 0.1%, respectively. It was the first drop in core PPI since 2015. On an annualized basis, both headline and core PPI were 1.7%.

The retail sales for July were 0.7% which reflected an increase of 0.3% from the previous month. Sales made via internet retailers climbed 2.8% for the month and excluding gasoline and automobiles, they were 5.6% year-over-year. This was

in comparison to 2.2% year-over-year in June. MarketWatch reported that "Sales also rose sharply at department stores, restaurants and electronics outlets. A spike in oil prices boosted sales at gas stations by 1.8%". Music stores, sporting goods stores and auto dealers experienced a decline in July sales.

The National Association of Realtors (NAR) said that concerns over the slowing economy and low supply of moderately price homes continue to affect the sale of homes, even with an environment of very low mortgage rates. The total existing-home sales gained 2.5% for the month to a seasonally adjusted annual rate of 5.42 million.

The Commerce Department said the gross domestic product (GDP) for the second quarter increased at an annualized rate of 2% which reflected a 0.1% downward revision from the previous month. The GDP for the first quarter was 3.1%. According to CNBC, "The U.S. economy slowed a bit more than initially thought in the second quarter as the strongest growth in consumer spending in $4\frac{1}{2}$ years was offset by declining exports and a smaller inventory build".

Portfolio Commentary: Performance, Diversification, and Strategy

The Treasurer's portfolio yielded 2.60% in August with a weighted average maturity of 818 days. The total assets under management by the treasurer was \$7.5 billion, in comparison to \$5.7 billion a year ago. The portfolio's diversification strategy continues to be sound. U.S. government sponsored enterprises accounted for approximately 28% of the portfolio and mortgage-backed securities were 42%. U.S. treasuries represented 18% of assets, money market mutual funds were 8% and Certificates of Deposits were 2%. State bond issues, foreign bonds and municipals totaled 1% and comprised the balance of funds invested. In keeping with the state's statutory investment objectives, the portfolio strategy continues to be seeking safety, liquidity, and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered in order to maximize income within investment parameters and with regard to the likelihood of stable interest rates.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 100% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

Securities were purchased or sold utilizing competitive bidding. Bank fees and money market mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at market value, include the State Treasurer's investments at \$4,865,639,945 and State Agency balances in OK Invest at \$2,687,187,483 for a total of \$7,552,827,428.



Office of the State Treasurer Portfolio Composition August 31, 2019





In February 2019, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2020. The amount estimated was \$115,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

The following page presents market rates of return on the Securities portion of the General Account and the State's aggregated State Agency Accounts. These figures, which are dollar-weighted and time-weighted where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month.

To ensure the integrity of data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are held with the custodian bank Northern Trust Company.



Securities Lending Program

The State Treasurer participates in a securities lending program with Northern Trust Company acting as lending agent. Northern Trust retains 20% of the revenues generated as compensation for services, their share for the month was \$2,675. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of security lending revenue in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.

Northern Trust Custody Fees

Pursuant to custodial contract with Northern Trust Company, custody fees are paid quarterly. Fees paid to Northern Trust Company for the first quarter was \$0.
