To the People of Oklahoma:

The Office of the State Treasurer is pleased to issue the April monthly investment performance report. I trust you will find it thorough, upholding my commitment to provide disclosure on the economic environment and portfolio results. As always, my staff and I are available to answer any questions, and I hope you find this information helpful.

Market Conditions for April

The treasury curve continued to be inverted, with shorter treasuries earning higher yields than longer maturities, with the inflection point being at six months. The 2-year came in at 4.00% and the yield on the 10-year treasury sank to 3.42%, reflecting its largest two-month decline since April 2020. The 30-year treasury was 0.02% higher than in March, with a yield of 3.67%.

All three of the major stock indexes reflected year-to-date gains at the end of April with the S&P 500 earning 8.6%, the Dow Jones at 2.9% and the NASDAQ returning 16.8%. As reported by Dow Jones Newswires, "Market volatility remained remarkably subdued for much of the month, with ebbing trading volumes and a prolonged stretch of muted moves for the major indexes."

The minutes from the Federal Reserve meeting in March were released and stated "several participants emphasized the need to retain flexibility and optionality in determining the appropriate stance of monetary policy given the highly uncertain economic outlook." According to The New York Times, "Central bankers have spent more than a year waging a battle against the most painful burst of price increases in decades, raising interest rates to slow the economy and to wrestle price increases under control. After lifting their main rate to nearly 5 percent over the past 12 months, policy makers are contemplating when to stop those moves. But that choice has been complicated by recent high-profile bank blowups."

Economic Developments for April

The unemployment rate slightly declined to 3.5% in March from 3.6% in February. Nonfarm payrolls came in at 236,000 which was below expectations. "Along with the payroll gains came a 0.3% increase in average hourly earnings, pushing the 12-month increase to 4.2%, the lowest level since June 2021. The average work week edged lower to 34.4 hours," according to CNBC. February nonfarm payrolls were upwardly revised by 15,000 to 326,000. Meanwhile, the payroll number for January was downwardly revised to 472,000 from 504,000.

The headline Consumer Price Index (CPI) was lower than expected for March coming in at a gain of 0.1%. This was in comparison to 0.4% for February. The month-over-month increase in the CPI was the lowest since June 2021. CNBC reported, "A 3.5% drop in energy costs and an unchanged food index helped keep headline inflation in check. Food at home fell 0.3%, the first drop since September 2020, though it is still up 8.4% from a year ago. Egg prices, which had been soaring, tumbled 10.9% for the month putting the 12-month increase at 36%." The Bureau of Labor Statistics (BLS) reported the Producer Price Index (PPI) for final demand declined 0.5% in March, on a seasonally adjusted basis. According to the BLS, prices for final demand less foods, energy, and trade services edged up 0.1% for the month after rising 0.2% in February.

Retail sales for February were upwardly revised from a decline of 0.4% to a decrease of 0.2%, and the month of March reflected another decline of 1.0%. Trading Economics reported, "Core retail sales which exclude automobiles, gasoline, building materials and food services, and relate more with the consumer spending component

of GDP, went down 0.3%." According to Reuters, "The decline in retail sales was almost across the board. Receipts at auto dealers dropped 1.6%. Furniture store sales fell 1.2%, while receipts at electronics and appliance stores tumbled 2.1%. Sales at building material and garden equipment supplies dealers plummeted 2.1%."

The sales of existing homes sagged to 2.4% month-over-month, in comparison to a downwardly revised gain in February of 13.8%. On an annual basis, sales came in at 4.44 million for existing homes. Reuters reported that the "Federal Reserve's aggressive interest rate hiking campaign has plunged the housing market into recession, with residential investment contracting for seven straight quarters, the longest such streak since the collapse of the housing bubble triggered by the 2007-09 Great Recession."

The real gross domestic product (GDP) for the first quarter of 2023 was reported at an annualized rate of 1.1%, in comparison to 2.6% for the last quarter of 2022. The Bureau of Economic Analysis (BEA) said private inventory decreased, reflecting wholesale trade dropping specifically in machinery, equipment and supplies. Manufacturing also declined, led by transportation equipment as well as petroleum and coal products. In addition, the BEA said that "within residential fixed investment, the leading contributor to the decrease was new single-family construction."

Portfolio Commentary: Performance, Diversification, and Strategy

The State Treasurer's portfolio yielded 2.36% in April with a weighted average maturity of 949 days. The total assets under management were \$15.5 billion, in comparison to \$12.1 billion a year ago. The portfolio's diversification strategy continues to be sound. U.S. government sponsored enterprises accounted for approximately 21% of the portfolio and mortgage-backed securities were 19%. U.S. treasuries represented 51% of assets, money market mutual funds were 8% and certificates of deposit were 0.3%. State bond issues and foreign bonds totaled 0.5% and comprised the balance of funds invested. In keeping with the state's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered to maximize income within investment parameters and rising interest rates.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 100% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

Securities were purchased or sold utilizing competitive bidding. Bank fees and money market mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the State Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment at market value include the State Treasurer's investments at \$12,348,742,591 and State Agency balances in OK Invest at \$3,143,119,713, for a total of \$15,491,862,304.







Portfolio Holdings as of 4/30/2023








The following page presents market rates of return on the Securities portion of the General Account and the State's aggregated State Agency Accounts. These figures, which are dollar-weighted and time-weighted where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month.

To ensure the integrity of data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are held with the custodian bank Northern Trust Company.



Securities Lending Program

The State Treasurer participates in a securities lending program with Northern Trust Company acting as lending agent. Northern Trust retains 20% of the revenues generated as compensation for services, their share for the month was \$15,847. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of security lending revenue in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.

Northern Trust Custody Fees

Pursuant to custodial contract with Northern Trust Company, custody fees are paid quarterly. Fees paid to Northern Trust Company for the first three quarters total to 33,750.
