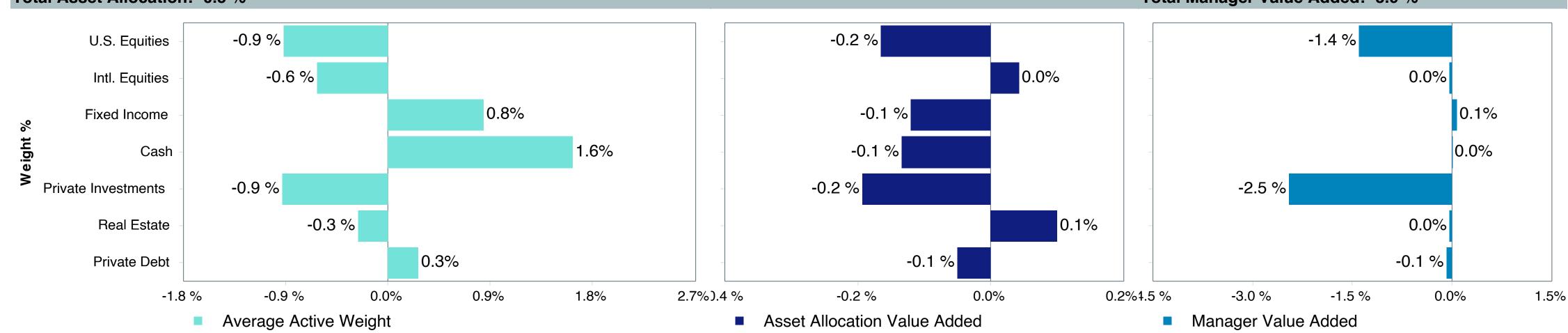




Total Fund Attribution - Policy Benchmark

1 Year Ending December 31, 2024



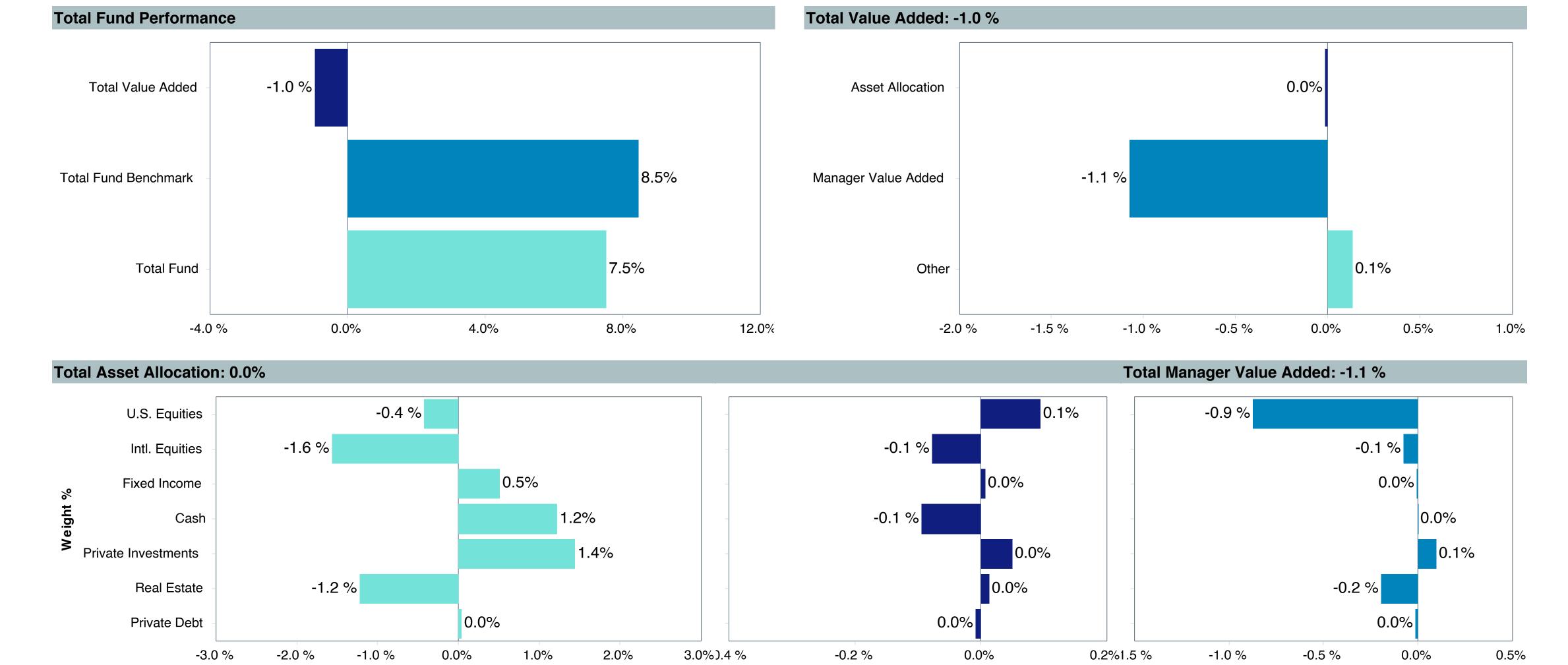




Total Fund Attribution - Policy Benchmark

Average Active Weight

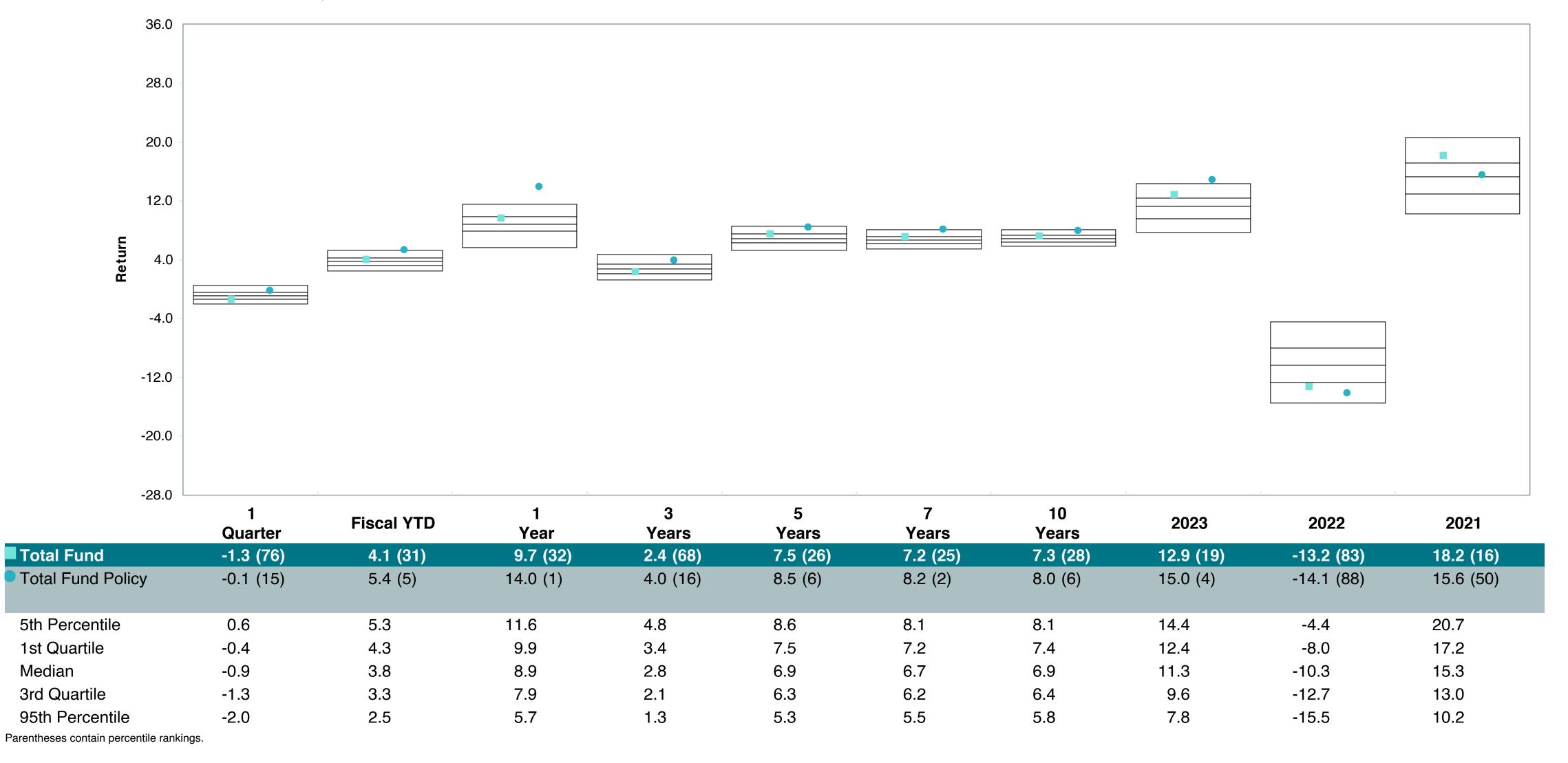

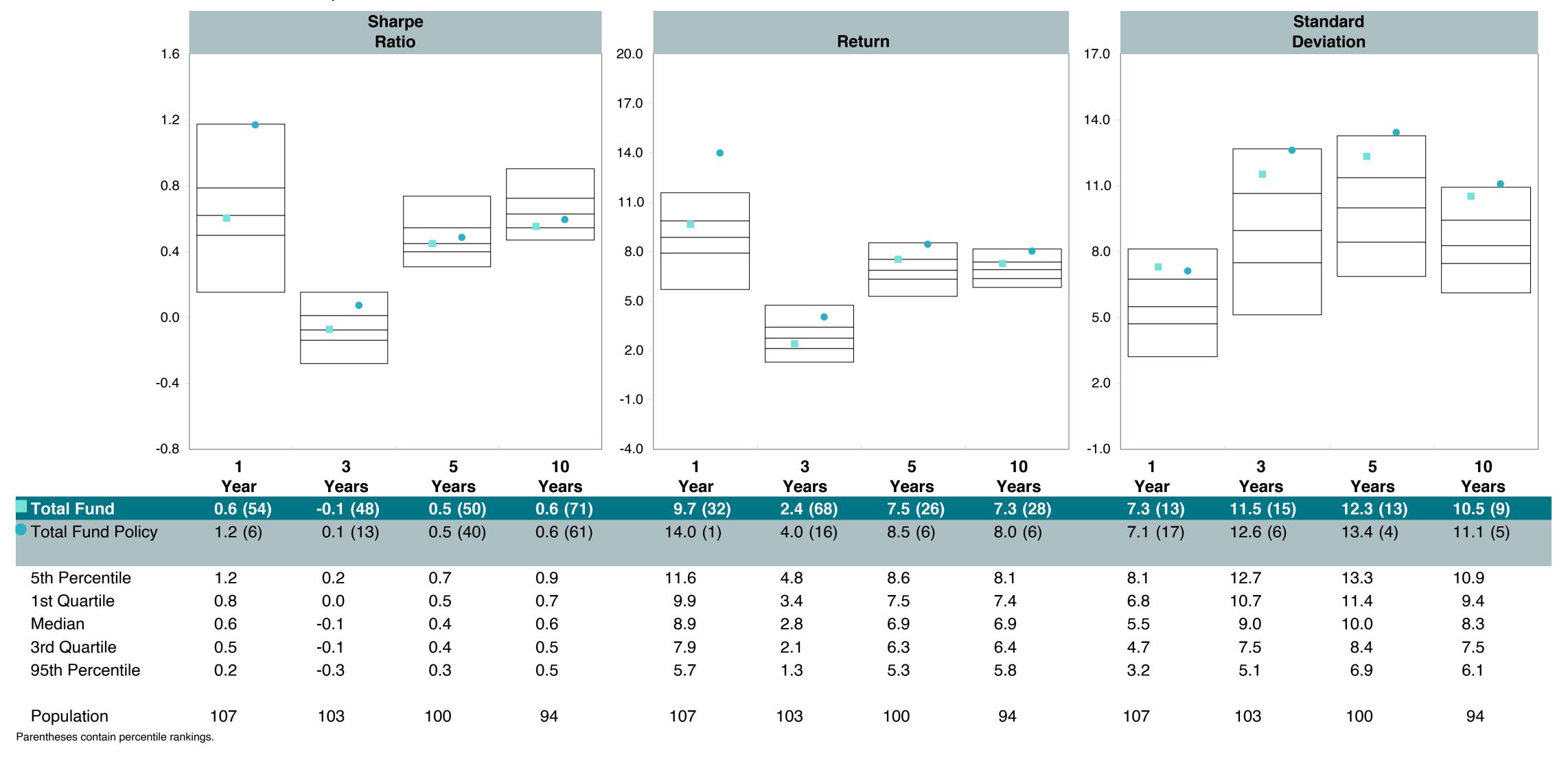

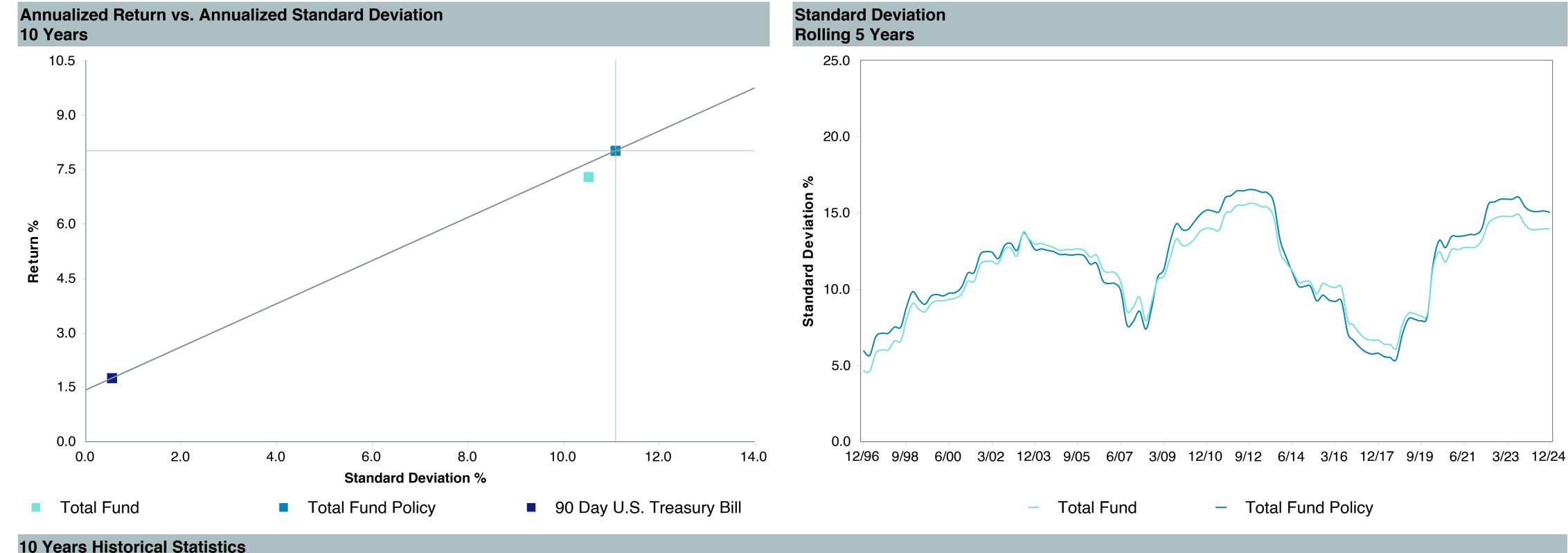

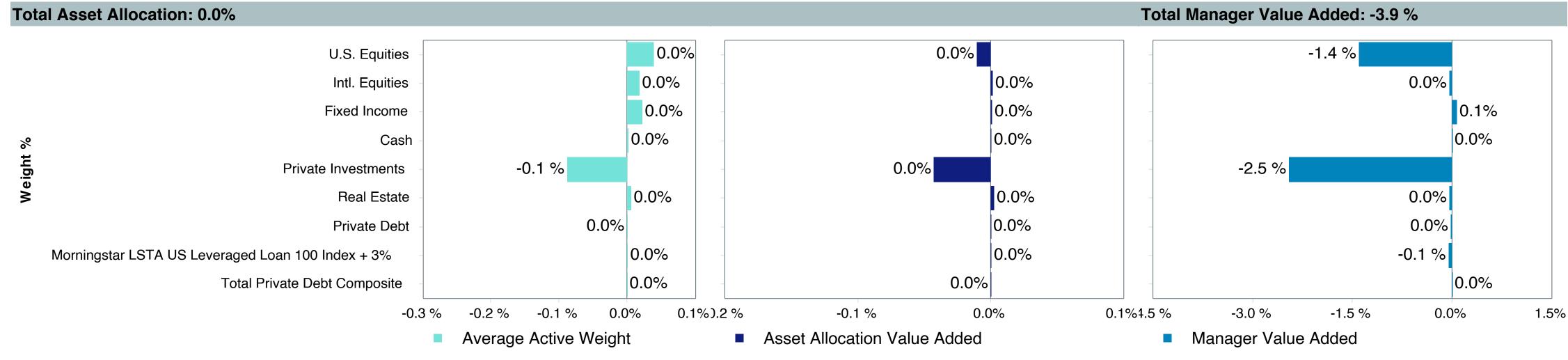




Total Fund Attribution - Allocation Benchmark

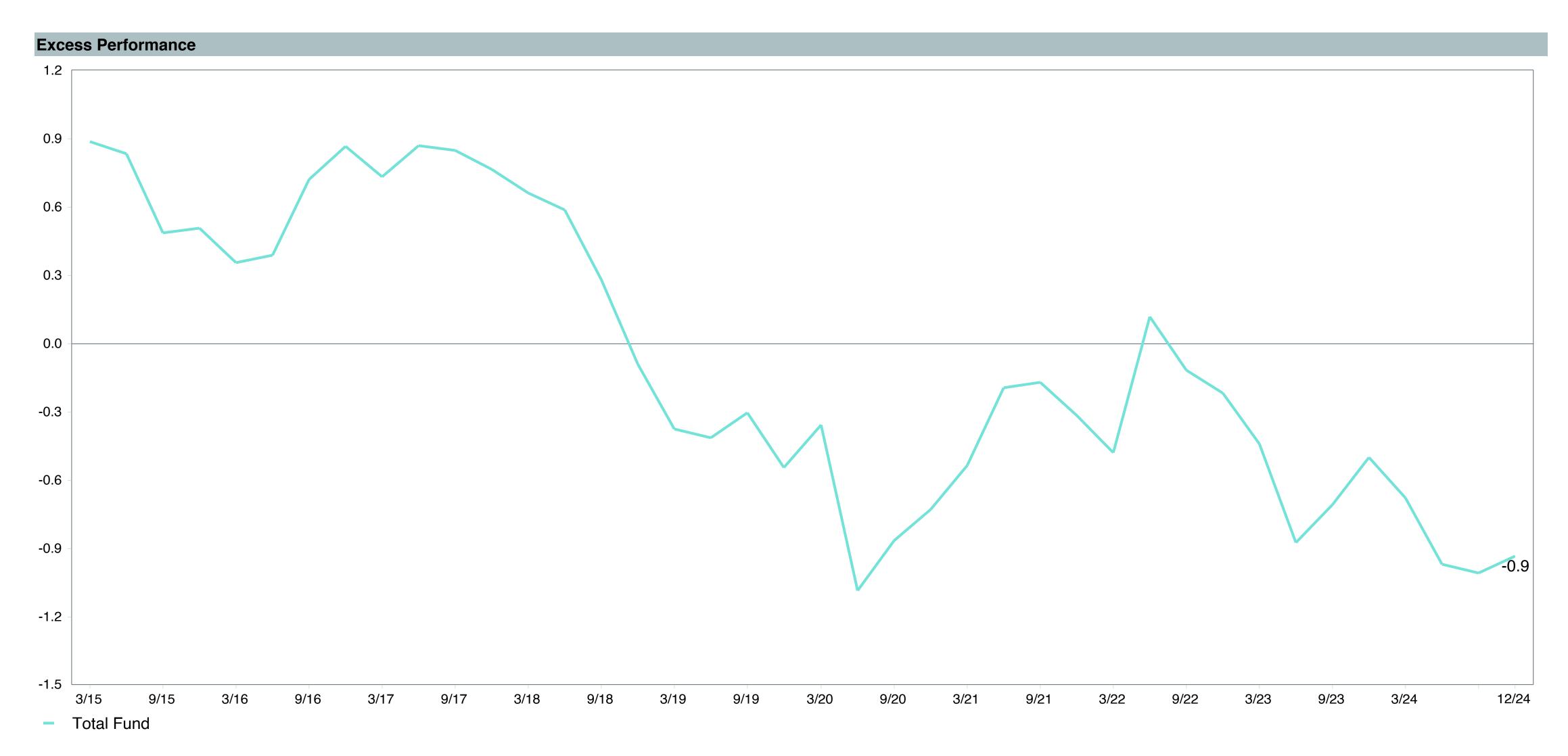

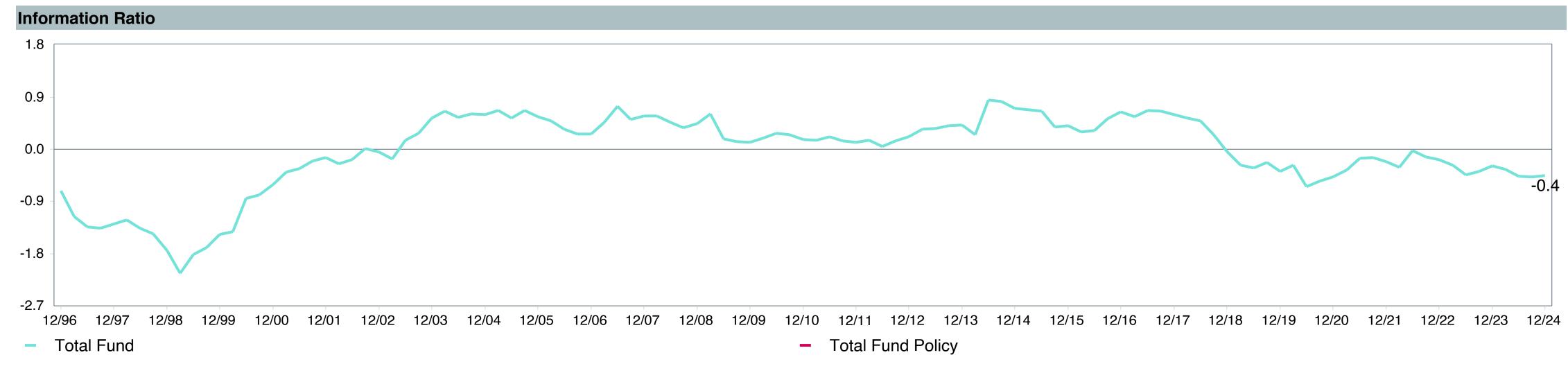


Rolling Five Years - Total Fund Excess Performance (vs. Total Fund Policy)

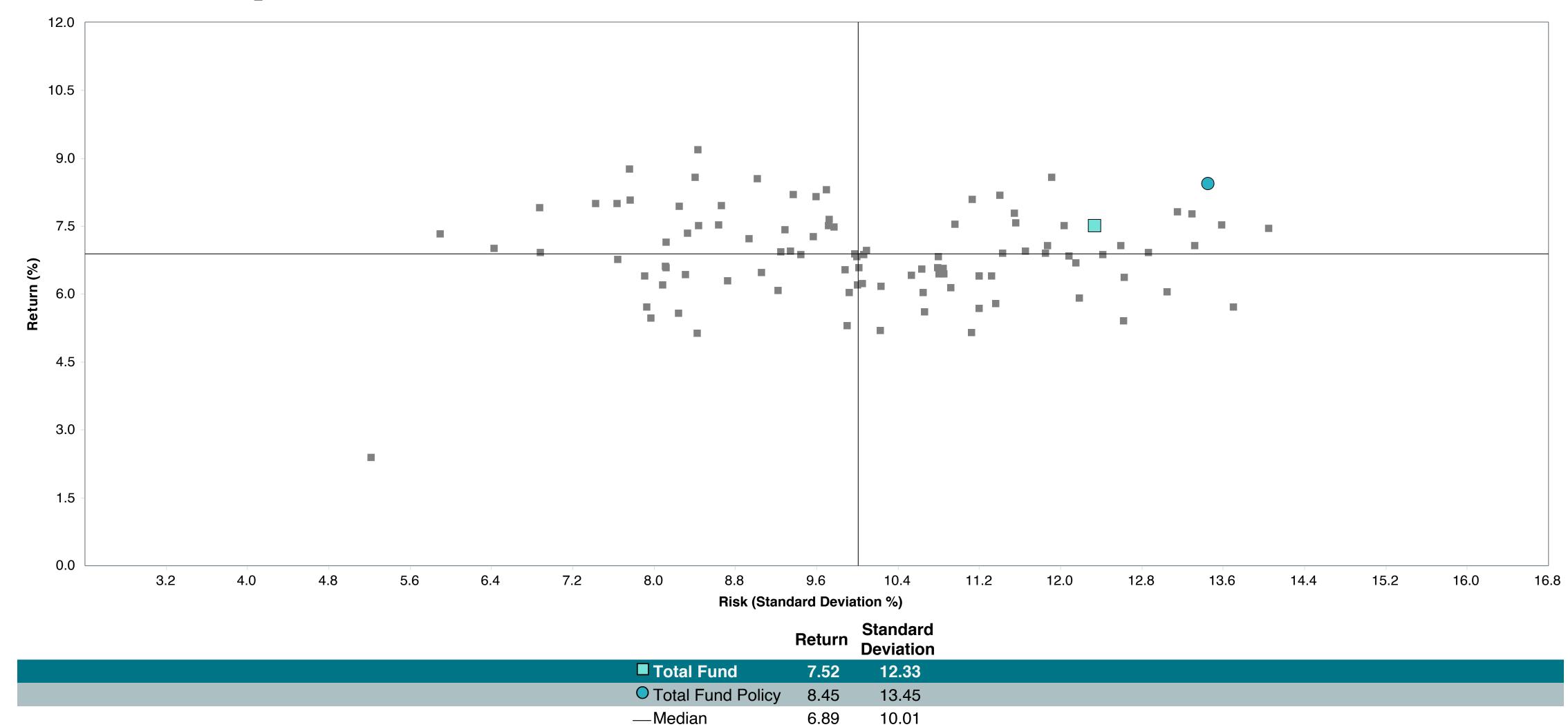

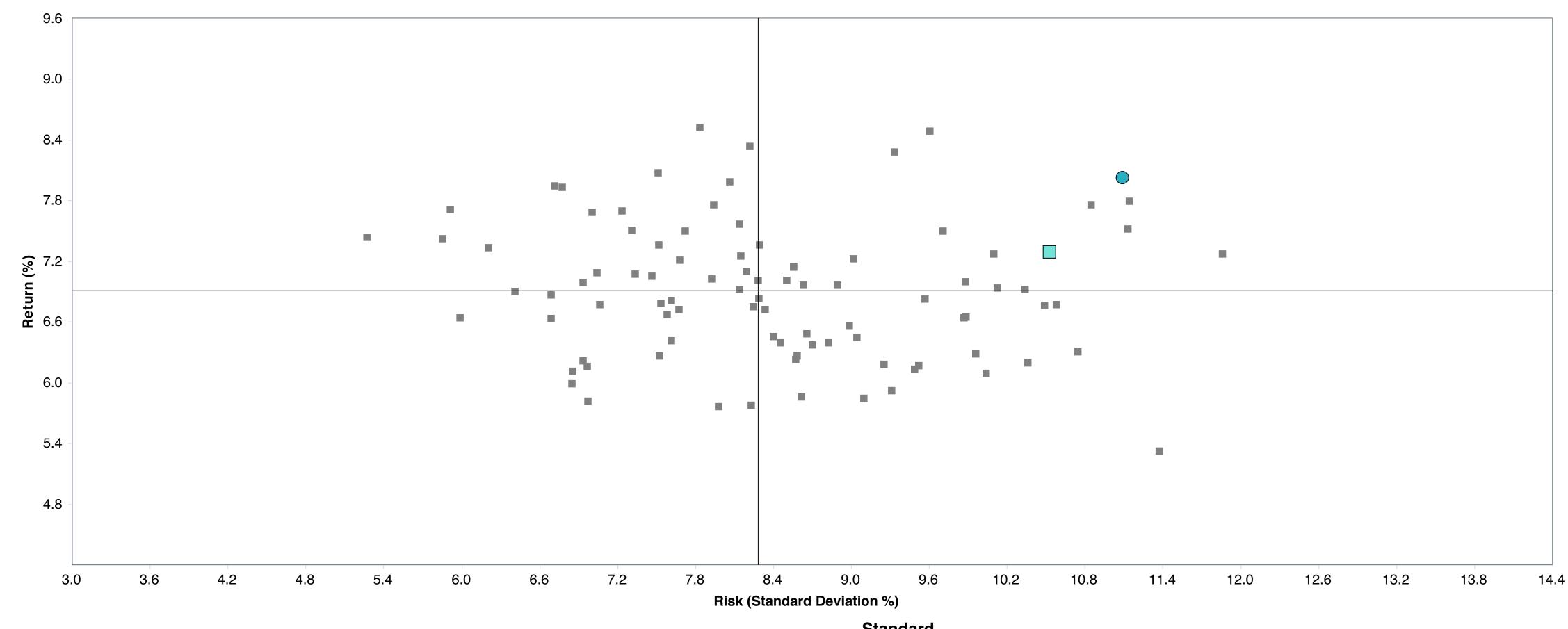

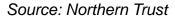
