## TSET Legacy Grants

### **TSET Legacy Grant**

- Historic opportunity to make significant health impacts across Oklahoma
- Focused on improving health through the prevention of the leading causes of death, cancer and cardiovascular disease
- Emphasis on rural health, healthcare access, early prevention, data gaps and quality of life improvements
- **Support** TSET's mandated purposes in the Oklahoma Constitution (Article 10, Section 40)

### **TSET Legacy Grant Funding**

- Funding amount: minimum of \$3 million per funding request
- Funding duration: between one to three years (CY26 CY28)
- Total grant pool: up to \$150 million. Awards will be made on strength of proposals.

### **TSET Legacy Grant Eligibility**

- Public institutions of higher education
- Public entities such as county/local government and public-school districts
- State agencies
- Not-for-profit 501c3 organizations, and
- Tribal entities

Organizations must be able to manage and expend funds for up to six months while awaiting reimbursement.

## Built Environment: Physical Activity and Nutrition – Statewide Request for Applications

Eligible Organizations:

- Oklahoma local governments (towns, cities, and counties),
- non-profit 501(c)3 organizations,
- tribal nations,
- institutions of higher education, and
- public entities (such as public-school districts/sites and state government)

## Built Environment Planning & Design Projects & Construction Implementation – Physical Activity

#### Overview:

- Total expected funding: up to \$4,600,000
- Maximum award & period: varies based on selection of either Planning & Design or Construction Implementation
- Scope of work varies based on selection of application type
- Performance Tracking reviewed on annual basis based on specific performance measures.

#### Nutrition and Access to Healthy Food Construction Implementation Projects

#### Overview:

- Total expected funding: up to \$1,500,000
- Maximum award & period: varies for Farmers' Market or Food Pantry
- Scope of work varies for Farmers' Markets, Food Pantries and Healthy Students in Schools
- Performance Tracking reviewed on annual basis based on specific performance measures.

# Preventing Youth Access to Tobacco Products (Pilot)

#### Overview:

- Eligible organizations from 32 listed counties to include:
   Oklahoma local governments (including county sheriff's
   departments), non-profit 501(c)3 organizations, tribal nations,
   and state government agencies.
- Total expected funding: up to \$120,000
- Maximum award & period: \$30,000 /yr for up to 3 years
- Scope of work includes 6 areas
- Performance Tracking reviewed on annual basis

#### Social Support for Physical Activity (Pilot)

#### Overview:

- Eligible organizations from 32 listed counties to include:
   Oklahoma local governments (towns, cities, and counties), non-profit 501(c)3 organizations, tribal nations, institutions of higher education, and public entities (such as public-school districts/sites, county health departments, and state government).
- Total expected funding: up to \$400,000
- Maximum award & period: \$100,000 /yr for up to 3 years
- Scope of work may include 3 areas and public promotion
- Performance Tracking reviewed on annual basis

# Management, Development & Expansion of Farmers' Market & Food Pantries (Pilot) Overview:

- Eligible organizations from 32 listed counties to include: Oklahoma local governments (towns, cities, and counties), non-profit 501(c)3 organizations, tribal nations, institutions of higher education, and public entities (such as public-school districts/sites, county health departments, and state government).
- Total expected funding: up to \$120,000
- Maximum award & period: \$30,000 /yr for up to 1 year
- Scope of work may include 3 areas and public promotion
- Performance Tracking reviewed on annual basis

#### New FY26 Program Framework

- Simplified application process
- Increased funding
- New single award category
- New award cycle
- Applications open to all eligible school districts and municipalities in FY26

#### New FY26 Program Framework

- School sites become eligible in FY27 after their districts receive a grant.
- Program budget increase to \$3 million annually

#### **FY26 Grant Criteria**

- Tobacco Use and Prevention
- Wellness policies and initiatives

Look for updated guidance documents to be posted on the TSET website in early July!

### **Project Plan and Budget**

- Applicants will submit budget requests and project plan for up to max. funding.
- Awarded Grantees will complete quarterly check-ins to report on project progress until completion.
- Awarded funds must be spent and project completed within one year of award.

#### **Funding Award Categories**

- School Districts enrollment
   ≤2,000 up to \$50,000
   ≥2,001 up to \$80,000
- Community population
   ≤4,299 up to \$60,000
   ≥4,300 up to \$100,000

#### **Coming in FY27**

School Site enrollment
 ≤600 up to \$25,000
 ≥601 up to \$40,000

- TSET will be moving most grants management to the Salesforce platform in FY26. Be sure to:
- Register your organization through the "<u>Funding</u> Portal" on the TSET website
- Where required, upload organizational documents such as:
  - Signed and dated Tobacco Free Policy
  - Signed and dated Workplace Wellness Policy
  - Workers Compensation Form
  - Non-acceptance of Tobacco Funding Form
