## Manufacturer/Distributor License Plate Application Instructions

Payment must accompany the application. Make checks payable to Service Oklahoma. The manufacturer number, if any, must appear on the check. A \$50.00 penalty will be assessed for any checks that can not be processed.

Replacement Plate and/or Decal: If any manufacturer plate and/or decal has been lost or stolen you must make a police report of the incident. You must include a copy of the <u>police report</u> with your application. <u>List the missing plate</u> and the decal number on the missing plate on the front of this application or on an additional sheet of paper. Damaged plates must be returned with your application. If you have a lost/stolen <u>decal only</u>, please contact Service Oklahoma/Dealer Plate Section.

**Renewals:** If you have a damaged manufacturer plate or plate you are not renewing, it must be returned with your application. Your renewal application cannot be processed until you have accounted for all plates in your possession. Decals for renewals cannot be issued until Service Oklahoma has been notified by the Oklahoma Motor Vehicle Commission that the manufacturer's license has been issued for the renewal year.

**Penalty Fees:** The license is non-assignable and expires December 31st of each year. If not renewed by that date, the

applicant will become subject to a penalty of \$0.25 per plate per day for a period of 31 days. After January

31st, the penalty will be \$10.00 per plate.

Mail Fees: \$6.60 per plate, \$1.73 per five decals (One to five decals = \$1.73; six to ten decals = \$3.46, etc.)

## Agreement

It is hereby agreed by and between the applicant and Service Oklahoma that:

- 1. Manufacturer plates will be revoked if the applicant has violated or violates any provisions of the laws of this state.
- 2. Separate licenses and license plates are required for each location owned or operated by the applicant.
- 3. The applicant will not use manufacturer plates issued in connection with this license on any second-hand or used vehicle, or any trailer or vehicle that is used as a service/loaner car, used for hire, or is for private use.
